
2006 President's Report

Our theme for 2006 has been Designing a Better Michigan through the AIA.

The Three Main Focus areas for the year were centered on AIA Michigan's Mission – Advocacy, Education and Fellowship. It is our belief that if we reach out to those outside of our profession and show them the power of design that we as architects can make a positive difference in our communities and the State.

ADVOCACY

On the advocacy front we had a very successful legislative day and Howling event. There were 57 architects that participated in visits to our State Representatives and Senators. We were welcomed to the event by our legislator of the year for 2006 Senator Mark Schauer of Battle Creek. Our agenda for this year included advocating for a certificate of merit bill and increased penalties for unlicensed practice. We were successful in getting sponsors for both of these bills. Representative John Pastor introduced House Bill 5948. If this bill becomes law, it would limit the number of frivolous actions filed against design professionals due to the up front requirement to engage an expert before a law suit could be filed. Representative Chris Ward introduced House Bill 5874. This bill would provide for increased penalties against those who practice Architecture without a license. Specifically, a third offense would become a felony. The bill passed the House and has been assigned to the Senate Committee on Economic Development, Small Business and Regulatory Reform. If this bill becomes law, interest on the part of local prosecutors in enforcement activities should increase. We also continue to fight the package of Interior Design licensing bills. Our goal for 2007 is to have at least 150 architects storm Lansing on March 20to again push for passage of the legislation that is important to protect our profession.

In October we had a tremendously successful event hosted by the Grand Valley Chapter to learn some lessons on how we can advocate for more cooperation on regional level regarding planning. The Mayor of Grand Rapids and the planning directors for the City of Grand

Rapids, Holland, Walker, North Shore, Muskegon Heights and the Charter Township of Holland spoke to our board about the vision and skill that architects bring to the urban planning process. Bob Daverman and the Grand Valley Chapter had conducted a regional planning Charette in January 2005 and the results have pushed regional cooperation, captured additional planning funds and have generated the vision of 75 planning charettes in the West Michigan area in the next 5 years. Greg Norton president of the West Michigan Strategic Alliance has advanced this vision and is seeking funding sources. This is clearly one area were architects are designing a better Michigan through the AIA. The next set of three planning charettes will be conducted early next year as part of the AIA 150 Blueprint for America project. A charette was also conducted by the Southwest Chapter this year for the Three Rivers area.

We strategically utilized our APAC funds to support legislators that have been supporters of the design profession. We conducted several fund raisers this year and supported 27 legislators.

EDUCATION

To support leadership development and continuing education we held three events.

Training conference for all the chapters. This event held at the Grand Traverse Resort is an opportunity for Chapter Presidents and Vice Presidents to join the AIA Michigan board for planning; sharing lessons learned and develop news idea for programs at the chapter level.


was filled with many worthwhile activities, which I have attempted to summarize for you in this report.

PLANNING FOR 2007 - AIA150

The most important responsibility for our Vice President is to plan for his or her year as President. GOVERNMENT AFFAIRS LIAISON AND APAC CHAIR

As Vice President, I had the opportunity to participate with our outstanding Government Affairs Committee. This was one of the busiest and most effective years yet in the political arena. Punctuated by a very successful Legislative Day in Lansing – held in conjunction with our lobbyist, Kelly Cawthorne, and the AELC (Architects and Engineers Legislative Committee), we worked on a myriad of important matters impacting the profession.

Fundraising for our Architects Political Action Committee is another responsibility for the Vice President. We appreciate every dollar contributed. As you might expect in an election year, our PAC spent a lot of the funds that had been contributed by you. While we are sensitive to the soft economy here in Michigan, we should not let our guard down. More issues than ever affecting the practice of architecture, are in play. We need all the legislative backing we can get and our PAC contributions play a key role in that. If every member gave what they could, we would be in a much better position to support our profession's political "friends."

WEB-SITE COMMITTEE

Another liaison responsibility, that of Public Affairs, led me to chair a Task Force created to (1) oversee the graphic upgrade of our AIA Michigan Web-Site, and (2) to serve in an advisory capacity for policies and practices regarding information published on the site. The Task Force includes representatives from our Staff, AIA Michigan, AIA Detroit and the MAF – the three organizations that contribute financially to the Web-Site. Assisted by Skidmore Inc. of Royal Oak, a new site design format has been established. Our web consultant, Mike Mosley, has begun applying the new design to our site which we plan to unveil at the January Leadership Conference.

PRESIDENTS' COUNCIL

AIA Michigan's Past-Presidents form our organizations' Presidents' Council. This group is intended to offer insights and guidance from their positions of experience, for the Vice President during that year of planning. Unfortunately, this valuable resource has not been utilized to its full advantage. This year I took the opportunity to make a formal recommendation to the Council that focused on having these leaders broaden their active involvement. I'm pleased to say that the proposal was endorsed and an annual "Opportunities for Involvement" form was developed to annually solicit greater participation by the members of the Presidents' Council. We look forward to their re-invigorated participation.

SUMMARY

In closing, permit me to share my excitement regarding the coming year. We have an opportunity to enhance our visibility in the communities we serve through a vigorous celebration centered around AIA150. Looking longer-range, however, we do have some challenges to overcome. Our membership base will most likely begin to shrink as the "babyboom" generation moves toward their retirement years. At the same time, the cost of our operations continues to increase, if even at a modest rate. This means that we will need to find new ways to expand our base of support and creatively increase our income. Our

AIAMI Government Report for 2006:

OVERVIEW:

We had a full year opposing legislation that is harmful to our profession (i.e. Interior Design Licensure) and supporting legislation (i.e. Increased Penalties, Statute of Limitations and Certificate of Merit) beneficial to our cause.

HIGHLIGHTS:

Interior Design Licensure Bill

As was it was in 2005, this was our primary focus throughout the year. House Bills 4262 and 4311 passed House in February and were referred to the Senate Committee on Economic Development, Small Business and Regulatory Reform. Through the efforts of our Lobbyist, Kelley Cawthorne and the committee we were successful in bottling these bill up in Committee where the died. This was a major victory for our profession. Unfortunately, we will have little time to celebrate new legislation will be introduced next year.

Legislative Day in March

We had a marginally successful day at this year's Legislative Day in Lansing. Participation was up from the dismal showing in 2005. Talking points for the day's visits included Certificate of Merit, Increase Penalties for Unlicensed Practice, Interior Design Licensure and Statute of Limitations. 2006 Legislator of the Year recipient, Representative Mark Schauer, kicked off the day with a few kind words. A much greater attendance in needed at the 2007 Legislative Day on March 21st and we urge that you attend. This is your chance to meet face to face with your legislators and voice your concerns.

DMB and the State Contract:

We understand that urged by the passing of HB5656 in 2004 DMB has decided to write a new state contract. A draft is due out soon and we are confident it will me a much fairer contract to design professionals.

Statute of Limitations:

Earlier this year the Michigan Supreme court overturned ten years of case law which limited the statute of limitations on professional malpractice to two years. Instead the Court decided that another statue ruled that extended the statute of limitations period to six years. With the help of Representative Phil LaJoy we introduced HB6437 which, if passed, would overturn the Court's ruling and reinstate the two year limit. Unfortunately, no action was taken by the Legislature this year so we will be re-introducing it in 2007.

Increased Penalties:

Representative Chris Ward sponsored House Bill 5874 which increased penalties for the unauthorized practice of architecture, professional engineering and professional land surveying. Unfortunately, this bill fell victim to the interior design controversy within the Legislature and it died. We will re-introduce this bill early in the 2007.

Certificate of Merit:

Two bills were introduced this year that would require a plaintiff to obtain a certificate of merit prior to filing a malpractice lawsuit against a design professional. House Bill 5948 and Senate Bill 1401 (sponsored by Senator Bruce Patterson) were not passed this session so they will be introduced again next year.

Legislator of the Year Award:

AIAMI will recognize the 2006 Legislator of the year for his support of issues critical to our profession.

Brief look ahead to 2006:

We will continue to oppose the Interior Design Licensure and will re-introduce legislation on Increased Penalties, Certificate of Merit and Statute of Limitations.

AIA150 BLUEPRINT FOR AMERICA INITIATIVES

ML&CO is participating as part of the committee for the AIA150 Blueprint for America initiative, and will continue to work closely with the committee to develop and execute various campaigns surrounding the initiative.

ML&CO has – and will continue to – participate in activities in support of the initiative statewide, which include but are not limited to:

The writing of the grant application on behalf of AIA Michigan to obtain funding for a booklet that will compile the results of Blueprint initiatives around the state, and be distributed to business and municipal leaders and decision makers, and other stakeholders around the state.

The outline for AIA Detroit's initiative, which will consist of an issues forum, to identify issues of importance with the Detroit region, to be followed by a problem solving forum, which will provide solutions to the problem via a charrette or other community visioning session.

STATUS: Outline is completed, was utilized as a template to complete the grant application on behalf of AIA Detroit.

Grant application was written, submitted and awarded.

Letter/invite was distributed to community and municipal leaders to attend the October forum.

ML&CO will work with AIAD to coordinate aspects of the event(s) and activities.

Letter to Michigan Governor Jennifer Granholm and other local leaders drafted and disseminated requesting a proclamation for architecture week in conjunction with statewide celebration.

STATUS: ML&CO/AIA in the process of following up with area leaders.

Coordinating media relations leading up to, during, and following AIA150 events.

STATUS: ML&CO scheduled a January meeting with John Gallagher of the Detroit Free Press, Dennis King and Victor Saroki to walk Mr. Gallagher through the AIA150 initiative. ML&CO will continue to pursue additional media opportunities and introductions with publications throughout the state, including the Detroit News, Grand Rapids Press, Lansing State Journal, Ann Arbor News, etc.

Companies that receive contracts work with DMB's Design and Construction Division. These staff members oversee the design, construction and renovation of nearly all State buildings.

To make it easier for architectural and engineering companies to do business with Michigan, Design and Construction staff are revising DMB's professional services contract and its Small-Project General Conditions for Construction document — commonly known as the "short form." Proposed professional services contract changes include a new section of common tasks that will help streamline contract terms. Changes to the short form will help align it with the

MICH Spec model for construction contracts. DMB hopes to have the documents ready to use by the end of 2007.

This quote from the past is our future. 2006 has been a year in which AIA National has committed itself to an aggressive agenda which will include politics, sustainability and a new focus on the architect as a member of a professional community. In 2007, the board adopted new public policies, a new strategic plan and a new mission statement:
