



AIA LAS VEGAS PRESIDENT'S MESSAGE

Dedication to the advancement of the profession has been the theme of Grassroots since its inception. Presidents, President-Elects and CACE members of local and state chapters will meet in our nation's capital to lobby for the promotion of architectural practice and passage of bills that will benefit those who participate in the profession, without prejudice.



This is the opportunity for individuals to rally together for a common goal and exchange ideas that will benefit our chapters. This was the birthplace of our own "Architecture Week," which we will be celebrating in conjunction with the Western Mountain Region Conference this fall.

Some of the major topics we will be reviewing with our State Representatives and Senators will be:

* Commercial Revitalization Tax Credit: To aid architects in their role in revitalizing distressed cities and towns.

* ISTEA Reauthorization: The Federal transportation policy that is particularly supportive of transportation enhancements, environmental planning, and community livability issues.

* School Construction & Renovation: Provide additional funds to make schools technologically ready and provide funding for new construction. We agree with the idea of Federal support, rather than Federal control, over school construction projects at the state and local levels.

* Disaster Assistance/Mitigation: Better preventive measures can help reduce disaster costs and help communities better withstand the structural challenges posed by natural disasters.

* Reauthorization of the National Historic Preservation Fund: We recommend reauthorizing the fund without major changes or amendments to the National Historic Preservation Act (NHPA). A notable recommended change to Section 107 of the Act would make the Capitol, The White House, and the Supreme Court all subject to the NHPA.



AIA NEVADA PRESIDENT'S MESSAGE

GOOD NEWS - BAD NEWS - GOOD NEWS

First the good news. We have selected a winner in the design competition for the logo of the upcoming Western Mountain Regional Conference. The design will be first shown at Grassroots the first week of February. We will make the formal presentation at our February membership meeting. This will be a fun way to get people interested in the WMR conference, hopefully interested enough to serve on a committee. There is a listing of the committees in this newsletter. We really need your help in the planning of the conference. If you want to be a chairperson, or just serve on the committee, please sign up.



Now the bad news. As I mentioned in the last newsletter, and at our January membership meeting, the boards of both AIA Las Vegas and AIA Nevada voted to make AIA Nevada self funding. AIA Nevada has traditionally been funded by assessing the individual chapters. The expenses for AIA Nevada have increased dramatically in the last few years, due to our more aggressive lobbying efforts. We hired a full time lobbyist and perhaps for the first time have a unified voice at the state legislature.

The Southern Nevada expenses for AIA Nevada can no longer be funded by AIA Las Vegas, or at least it cannot without significant cuts in the programs now offered. It is our desire to continue to make AIA Las Vegas a vital professional organization. It is with this in mind that the boards voted to ask the membership to create a state dues. We decided on a \$75 state dues for only the Architect members of our chapter. This would not affect the Associate or Allied members. It is too late to create a formal dues change for 1998, so we will ask for a special assessment for 1998, with the formalized state dues beginning in 1999.

This does require a vote of the membership. There will be time allocated in the February membership meeting to answer all of your questions regarding this dues increase and the chapter's finances. The vote will be taken at the March membership meeting with yes votes from 2/3 of the architect members present required to enact this increase.

AIA LAS VEGAS PRESIDENT'S MESSAGE

* **BROWNFIELDS:** Legislation that accelerates the conversion of Brownfield sites to productive use through tax incentives. The term Brownfields is typically used to describe abandoned or underutilized properties, often former industrial facilities.

* **Private Activity Bond Volume Cap Increase:** Under current law, interest on certain State and Local "Private Activity Bonds" is excluded from income when a government incurs this debt as a conduit to provide financing for other private parties, if the financed activities are specified in the Internal Revenue Code. We support responsible public financing instruments which would increase economic development, home ownership, and affordable housing initiatives.

* **Qualifications-Based Selection:** Provides for vigorous and open competition among A/E firms in the areas of competence, experience, prior performance, and technical qualifications.

* **TORT Reform:** Legislation addressing lawsuit reform is essential for protecting Architects and other design professionals from liability cases that adversely affect the performance of professional practice.

These are our issues. The platform on which this year will be built. Many members are already involved in their realization. We need your input.

It has been an exciting first year as a member of the AIA National Board. The new board members have come on board and Raj Barr-Kumar, FAIA, has turned over the presidency to Ronald Altoon, FAIA, from Los Angeles who will be an excellent leader for our profession. Raj's year ended without bestowing the Gold Medal. The finalist for this prestigious award was Ralph Rapson, FAIA from Minnesota. He could not gather the necessary 3/4 vote of support required to award the medal. However, Norman Koonce, FAIA, President of the American Architectural Foundation, was selected as the worthy recipient of the Edward C. Kemper Award.

Raj's focus for the board last year was what AIA stands for: Advancement, Information and Advocacy. We worked the entire year on strengthening these goals.

Mark Hurwitz, Ph.D., our new CEO, is an excellent choice for this important job. He has years of education and experience as CEO of organizations similar to the AIA. We are fortunate to have him on board. The AIA staff and board is looking forward to working with him. Mark was definitely the best of all candidates for this position and plans to work well with CACE as well as the Board of Directors.


The newly revised AIA documents A201 and B141 are now available to members. They are endorsed by the Associated General Contractors and reflect redefinition of the Profession as it has evolved from the Practice and Prosperity Theme. The Practice and Prosperity Task Force helped us redefine the profession by providing us with expanded practice opportunities beyond our normal methods of service to our clients. With these documents we can now venture into the areas of asset management and manage risk, not merely avoid it in order to add value and another incentive to our clients. After all, no one knows the building better than the architect.

One of the great accomplishments this past year has been our new alliance with Architectural Record published by McGraw Hill. This relationship has brought the AIA to Business Week forums, business and trade development meetings, and many similar events where architects have been absent for too long. The first annual Business Week/Architectural Record Awards drew this lead from a 14-page Business Week (6 million circulation) article: "Want to save \$250 million over 10 years? Boost employee creativity? Reinvent an old company?" Conceptualize a new one? Recycle a factory into offices? Rework how you work? Discover your true corporate soul? HIRE AN ARCHITECT." This is great information that we have always wanted the public to know.

The AIA serves its members on many fronts but the most visible is the National Convention. This year it will be free of charge to all members. This is a huge savings. In 1994 the convention cost \$330.00. The 1998 San Francisco Convention will have 100,000 sf of exhibits this year and members can earn the entire year requirement of Continuing Education Units at this one-stop shop.

A slate of candidates has been announced for Offices of President Elect, Vice President, and Secretary. Our own Pat Rehse, FAIA is a candidate for First Vice President and John Anderson, FAIA is a candidate for Vice President. I encourage you to follow the activities of these candidates in the AIArchitect and actively participate in the elections next May in San Francisco.

John Anderson, FAIA and I have been assigned to the Library and Archives Task Force to study the myriad of issues surrounding this important part of the AIA. Later this year we hope to be able to recommend how the Library and Archives can best serve the membership. Marvin Sparr, FAIA of Boulder, Colorado took John Anderson FAIA's place as Director on the board last month. Marvin will serve us well and I look forward to working with him. We will each visit three states in our region this year. See you then.

THE QUESTION OF GROWTH

At the December meeting, Windom Kimsey presented the "State of the Chapter" report to sum up the progress and advances of the past year. No question about it...AIA Las Vegas has enjoyed a tremendous growth, and improved and increased member benefits over the last three years. Growth is a positive thing and we certainly want to continue, but it brings with it increased expenses for operations, services and providing member benefits for all.

Six percent of the Chapter's expenses last year (roughly \$14,000.) went to fund AIA Nevada and to provide legislative representation for all members of the profession. This is an extremely important member benefit and one that will continue to gain prominence in our agenda as the Chapter continues to grow. Funding for AIA Nevada is based on membership—33% from AIA Northern Nevada and 67% from Las Vegas. In 1998 AIA Las Vegas will be required to provide \$16,900. for legislative affairs and lobbyist activities. Since we do not want to cut or change the services that are currently being provided through AIA, we must look to other alternatives for funding at the State level. This year an assessment of \$75.00 from each Architect Member would make it possible to continue to provide legislative representation and work on the issues that impact the profession. In 1999 it will be necessary for AIA Nevada to institute State Dues to fund their operations.

THE FOLLOWING ARE THE HIGHLIGHTS FROM 1997:

- * Membership Increased by 26% this year. (81 new members in 1997 brought total Chapter membership to 330.)
- * Meeting Attendance has increased by 75% over the last two years. (In 1995 meeting attendance averaged 40-50. In 1996 it grew to 80-100 per meeting. 1997 saw an increase to an average of 140-160 per meeting.) Currently, 50% of our membership attends our monthly meetings regularly.
- * Meeting costs have increased dramatically. The average cost per meal is \$25.00 X 150 members per meeting = \$3,750.00 (This cost does not include speaker fees, equipment or location fees.)
- * AIA LV provided 22 CE Programs this year, which provided 113 CE Credits (3 times as many as required) and 59 Hours of HSW (7 times as many as required). 43 of these credits were provided through AIA Monthly Membership Meetings.
- * 93% of our AIA LV Members achieved their required 36 CE Credits.







The client for this time share resort desired an informal and comfortable, yet elegant look to establish a distinctive identity for the project. To that end, JMA Architecture Studios combined Mediterranean and Classical architectural elements. The color scheme will be neutral shades of taupe accented with periwinkle, chosen to not only complement the existing Las Vegas Hilton facilities, but also to further enhance the informal quality of the project.

The elevations were influenced by the classical tripartite tradition, with a definite base, body and capital. Mediterranean influences can be seen in the use of color and materials. The octagonal shape is a theme used throughout the project,

evident in the stair towers, central elevator tower, public spaces, and even the pool.

Functionally, the project consists of 16 levels plus a full basement, housing 232 units of one and two bedroom floor plans. Centralized meeting areas, divided between quiet and active functions, overlook the pool deck. The project amenities meet RCI standards, including pool and spa facilities, health club, dining facilities, and a sundries shop.

The project will be constructed with post-tension slab and cast in place concrete. The elevation is accented with reveals and layered with color, to give the facade greater visual depth.



GRASSROOTS CAMPAIGNING - HELP A CANDIDATE

Since the AIA and its members have established a presence in the Nevada legislative process, many members have expressed an interest in getting involved in campaigns. While many people feel the only way to have an impact is through donations made by a Political Action Committee, there is a way that is sometimes even more effective: grassroots campaign activity. The heart of this is volunteering to help a candidate.

While money is needed to pay postage, buy advertising and print signs, volunteers are needed to walk in the district, prepare mailings, make phone calls, introduce the candidate to other voters, and a variety of other tasks. Besides giving AIA members the chance to learn more about the candidates, it allows future legislators an opportunity to learn about our issues. More importantly, it gives legislators a person they know and trust to ask questions of when bills come up that affect the profession.

Legislators are elected to vote in a way that represents their constituents, 99% of whom never contact their Senator or Assemblyman. The few that do, particularly those who take the time to make some personal contact, are very important. Few things capture a lawmaker's attention like a well-written letter or a phone call from someone they know and feel comfortable about. Absent a strong personal conviction or an abundance of calls or letters in opposition, your contact with that Legislator is the constituent input on an issue, and the reason to vote a particular way.

How do you get involved? The first step is to find out what district you live and/or work in, and the candidates for the Nevada Senate or Assembly in that district. Call your local registrar of voters and tell them your address (*and register to vote if you have not already!*) and they can tell you the names and addresses of the candidates. Then ask friends, colleagues, or an AIA Board member if they know anything about these people. AIA lobbyists Fred and Mike Hillerby will always be happy to answer questions about any race.

After you've decided on a candidate, call them and introduce yourself, tell them you are an architect and would like to meet them and help on their campaign. Decide in advance what kinds of things you are willing to do. Among the effective techniques are:

Walking door-to-door with the candidate. This is probably the best way to get to know them. They also get to know and trust you as an individual, and as an architect.

Offer your own or your staff's time to make copies, stuff envelopes, or mail flyers. If you can, contribute the paper, copier time or postage to the campaign.

Offer the use of your office for evening or weekend phone-athons.

Display flyers and signs in your office, home or other locations.

Maintain a portion of the candidates signs. Have them give you a map, and promise to check on the condition of the signs, keep extras in your car so you can replace any you see missing or vandalized, and most importantly, agree to collect all of the signs on your route the week after the election and return them to the candidate. (This has been extremely effective for other groups.)

Hold a reception at your home, office or social club for the candidate. Introduce them to other voters in their district and encourage guests to donate to the campaign.

Don't worry about discussing architecture all the time. Get to know the candidate as a person, and give them the same opportunity with you. Establish your credibility as a person they can trust and a good source of expertise on our issues.

The payoff for all this work comes when the legislature is in session and lawmakers have questions about a bill that affects architects. They know they have someone they can call personally to get information and advice on the bill. Remember, these people are just like the rest of us, and they are asked in a given day to make decisions about architecture, medicine, cosmetology, the state budget, raising taxes, sentencing criminals, utility rates and an endless variety of other issues. Since they can not be an expert on all of them, they need to be able to talk to experts they trust. Give the lawmakers your phone numbers, and let your staff and co-workers know that you can always be interrupted when they call with a question.

As a lobbyist, one of the most effective tools at my disposal is the ability to answer a lawmaker's question by having someone they know and trust in the profession talk to them personally. The legislator now has an answer they feel comfortable with, and has faith that the AIA is a credible and reliable source for accurate information.

If you decide to volunteer, please let the AIA know who you are working with, so we know who to call if we have questions. Also, remember that you represent not only yourself, but your firm, the profession, and the AIA. Volunteering can be rewarding, fun, and an informative look at the legislative process.

As you may know, the PECG Initiative would end QBS for state-funded projects over \$50,000, and require the state controller's office to review every state-funded project to determine whether public employees could complete the project cheaper than the private sector.
