



Remember, change is good. Right?







### **Architectural Tour:**

**Saturday, Oct. 10 - Lunch Provided. Meet your bus and tour guide at the Bally's Tour Entrance**

**Bus leaves promptly at 12:15PM - 8 C.E. Credits - \$35.00**

Participants in this program will be given a geologic history of the Las Vegas Valley, provided by **David Weide, Ph.D., Professor of Geology at UNLV**. This will begin with a videotape presentation during the bus trip to Red Rock Canyon, an historic and geologically significant sight. Dr. Weide's presentation will cover the pre-historic events that formed the valley and shaped today's desert environment. Following this presentation, participants will see how this geologic history has influenced the design and construction of structures today. **Robert A. Fielden, FAIA and Jane Fielden** will be guides for this portion of the tour and will provide history and commentary on significant buildings including the **West Sahara Library, Community College of Southern Nevada, Charleston Library, The Clark County Government Center**, (where the desert environment is captured in the design of the building) **Las Vegas Library and Lied Children's Museum** designed by Antoine Predock and the **Clark County Library (Flamingo Library)** designed by Michael Graves. Participants in this tour program will come away with a broader knowledge of the geologic and environmental influences manifested in the design of awarding-winning architecture in Las Vegas.

Participants in this walking tour program will witness the significant differences between the original old Las Vegas structures and the newer attractions like Fremont Street and the revitalization of the downtown area. The tour will be conducted by **Frank Wright, noted historian and commentator** with KUNV Radio. It will begin at the Fifth Street School Building, originally constructed in 1936. Currently used for as office space, it is the proposed heart of the new "Arts District" for Las Vegas. This tour will include vivid recollections of the colorful history of Las Vegas and while many of the structures referenced have been renovated or replaced, their sites and significance will be noted. The Golden Gate Casino is the oldest structure in the downtown area dating from 1906. The tour will include many buildings from the 1920's and 30's. The old Las Vegas High School neighborhood dates from the 1930's and many of the houses and buildings of that era still exist.

The "Paris- Las Vegas Hotel & Casino" is a 3 million sq. ft. project, with 2,914 guest rooms, 300 suites, 85,000 sq. ft of Casino space, and 32,000 sq. ft. of retail space. In addition to the hotel with meeting rooms, there are 130,000 sq. ft of convention area, 13 restaurants and, a 25,000 sq. ft. Health spa. The project also includes a 50 story replica of the Eiffel Tower. The design plan incorporates art nouveau sculptures and French impressionist paintings, along with replicas of many other Parisian landmarks including the Arc de Triomphe, Paris Opera House, Parc Monceau and rue de la Paix. Participants will learn how hotels and casinos are designed for traffic flow and control, in addition to public health safety and welfare considerations. The tour will include all areas under construction including maintenance and operations areas as well as public corridors, shops, restaurants and entertainment areas. Participants will leave with a better understanding of what is involved in the design and construction of a successful resort complex.




