




I am going to make ten new year's resolutions for our Chapter, and I hope we can all make them come true in 1998.

The AIA State Government round table discussion on building codes was recently held in Nashville Tennessee. 45 states including Nevada were represented. The discussion centered around two important issues. The first was how states who have not adopted a single statewide model code can work to have one adopted. The second topic was the evolution of a single International model code and its future adoption by jurisdictions which now utilize the BOCA, Standard, or Uniform building codes.



Discussion regarding how states which do not utilize a single model building code listed above can work toward this goal. However, it is very important that in states where a single code is not utilized all jurisdictions adopt one of the three codes listed above.

This is due to the fact that the International Code will replace the three model codes as the scheduled update of each publication occurs.

One very significant fact is the Justice Department is working with the International Code Council (ICC) and others to include definitive rules regarding ADA issues. We must wait to see if this comes to reality. Another change which will occur is the allowance of performance based solutions. An example of an open ended breezeway being accepted by a specific jurisdiction in lieu of an exit corridor was given. A computer model was used to prove the equivalency of the system. As in the past, the new code will also prescribe descriptive solutions.

The single point which disturbed me was that the AIA is lobbying the ICC to include only Architects and Engineers in the code definition of Design Professionals. If they are successful it will be necessary for Nevada to amend this to include Landscape Architects, Residential Designers, and Interior Designers.

Copies of all conference handout materials are on file in the Las Vegas office of AIA Nevada, and a draft of the new code will be forwarded to us by National.

I have enjoyed serving as president of the AIA Nevada in 1997. Good Luck Brad!

NATIONAL NEWS:

Mark W. Hurwitz, Ph.D., CAE, Executive Vice President of the Building Owners and Managers Association (BOMA) International has been named Executive Vice President/Chief Executive Officer of The American Institute of Architects (AIA) effective January 1998.

PUBLIC PERCEPTIONS OF THE ARCHITECT

In August, the AIA commissioned comprehensive market research to assess current public attitudes about architects and their value to clients and the community. While this study is vital to the creation of national television and print advertising planned by the AIA for introduction in 1999, the research also identifies issues impacting the profession's ability to achieve greater influence with the public. Therefore the study has been summarized for AIA members, architecture students and instructors. A 15 minute video is available from the AIA National Public Affairs office which summarizes the new research on the public message strategy AIA should use in the proposed new TV ad campaign. The new research was made possible through the member dues assessment authorized at the last AIA National convention. The current short video will serve to update members on current planning for a new, broader TV ad campaign planned to start in 1999.

Between now and the December national board meeting, AIA's advertising agency will test market potential creative concepts for the new campaign. The most viable "story boards" will be presented to the AIA Board in December. Following this meeting the agency will make further refinements to the campaign prepare a '99 media plan and present the entire program for comment at Grassroots '98.

A copy of the written report is available through the AIA Las Vegas office, and the 20 minute videotape that accompanies the report can be borrowed for 2 days.

AIA LIBRARY UPDATE

Last month's article regarding the future of the national AIA Library and Archives generated a great deal of interest, and as a result we have received the following updated information.

The AIA Board of Directors and management are committed to safeguarding and enhancing the valuable collections of the AIA Library and Archives. The Institute, as a professional society, recognizes its obligation to the public trust to preserve the integrity of historic materials in its possession so that they may always be available to AIA members, outside scholars and related institutions.

The AIA Board, with the assistance of the AIA Education Department staff, Library staff and outside experts, is evaluating selected functions of the AIA Library. The goal is a simple one: to identify ways to improve access to library and archive resources, increase the services available and match them to current professional needs, and stimulate greater AIA member understanding and use of the resources. The goal of the evaluation is not to eliminate the AIA library.

Further, the evaluation does not involve the permanent collections of The American Architectural Foundation and the Octagon Museum, including the prints and drawings.

The AIA Library evaluation team, which includes four members of the AIA Board, is proceeding in a careful, deliberate and scholarly fashion. Haste is not a criterion for this study. The team will report its preliminary direction to the AIA Board in early December.

We all need a strong 21st Century Library to serve our members' expanding needs in the future.

NEVADA DEPARTMENT OF TRANSPORTATION PREQUALIFICATION NOTICE

The Nevada Department of Transportation (NDOT) expects that in the future it may request proposals from consulting firms for the services listed below. For the purpose of soliciting the proposals and in accordance with 23CFR172, entitled "Administration of Related Service Contracts", the NDOT maintains lists of responsible prequalified firms that possess the ability to successfully perform needed services.

This is an annual solicitation for prequalification and has no cutoff date for submissions. NDOT is always open to receipt of prequalification statements from interested firms. Prequalification lists are maintained for a period of two (2) years. The new prequalification period will be effective January 1, 1998 through December 31, 1999. If you are currently on NDOT's prequalification list(s), you must resubmit prequalification forms for each discipline because all current lists will be purged on December 31, 1997.

Submittal(s) to the prequalification lists should be addressed to the Nevada Department of Transportation, Agreement Services, 1263 South Stewart Street, Carson City, NV 89712 for EACH discipline in which the consultant wishes to be considered. Prequalification submittals may be combined into one package for each NDOT Division. Should you choose to submit a combined package for each NDOT Division, please indicate each of the disciplines in that respective division for which you seek prequalification, separating each discipline with a tab. Consulting firms possessing demonstrable expertise in these areas are encouraged to submit. Minority Business Enterprise and Women's Business Enterprise firms are expressly invited to submit as most of NDOT's projects have specific requirements relative to Affirmative Action Program activities.

Included in the prequalification submittal should be general information on the firm, the firm's brochure, experience of the firm (Standard Form 254) and a resume (Standard Form 255) of key personnel expected to be available for assignment to engineering contracts with NDOT. Non-Engineering consultants should contact NDOT for the applicable Statement of Prequalification Form.

Additionally, all interested firms must submit a detailed statement indicating the organizational structure under which the firm proposes to conduct business. The relationship to any "parent" firm or subsidiary with any of the parties concerned must be clearly defined. Further, the firm shall provide a statement of any and all contracts with NDOT which are currently being performed and a statement whether the professional consultant or firm performed services under any name other than the one appearing in the response.

Personnel in responsible charge of any engineering work are required to possess and maintain a valid Nevada Professional Engineer's License or in the case of right-of-way and surveying a Nevada Professional Land Surveyors License. Those in charge of architectural work are required to possess and maintain a Nevada Professional Architect License. All licenses are required at the time of prequalification.
