
Season's Greetings

AIA NEVADA PRESIDENT'S MESSAGE

We are moving toward the end of the year. The elections are behind us. Even though my plea for you to vote in last month's newsletter came out the day after the election, the issues AIA supported passed, including the CCSD bond issue and the 1/4 cent sales tax. Kelly Thomas was elected to State Assembly. He will be a great asset to our legislative efforts.



An issue has been brought to our attention. Nick Wieczorek, of Wieczorek & Associates, explained to the board the current "Wildcreek Garden" suit that is testing the Nevada Statutes of Limitations/Statute of Repose in the State Supreme Court. The results of this trial could leave architects with open-ended exposure. We have been asked to help prepare an amicus brief (friend of the court) stating our concerns. This is an expensive process \$25,000. We are looking to AIA National for funding. We will be filing this in conjunction with the engineers, who will also contribute. If you have questions regarding this issue or wish to contribute to help fight this please contact Randy at the AIA office.

There were no great changes in the State Legislature besides the addition of Kelly Thomas. We are preparing for our visit to Carson City next spring to speak to a number of key legislators. Fred Hillerby is keeping us appraised of any activity that could effect our profession.

The AIA Nevada web page is improving. There is now more information from Northern Nevada. We are anticipating publishing the newsletter on the web by the middle of next year. We will continue to print a newsletter, however, the number of copies we mail out will be greatly reduced once we publish on the web. This will be a substantial cost savings to both chapters. YEAR END UPDATE FROM AIA GOVERNMENT & INDUSTRY AFFAIRS

After a budget battle and many last minute details, the 105th Congress drew to a close on October 21. The year saw many victories for AIA members, including increases in the construction budgets of most of the major federal agencies. Other victories included passage of tax benefits and the Transportation Equity Act. Following is the status on areas on interest:

Commercial Revitalization Tax Credit: Battle wages on. Taken out of the tax package, this will no doubt be brought up next year.

Transportation Equity Act (TEA-21): Victory! Enhancements programs constitute \$3.8 billion of the \$217 billion spending bill. This means business for architects.

School Construction and Renovation: Battle wages on. Next year, the pressure will be on to pass legislation to improve learning environments. The AIA will be at the forefront.

National Historic Preservation Fund: Victory! The NHPF was reauthorized at \$712.4 million, providing funding to state historic preservation offices and others.

Private Activity Bond Volume Cap: *Victory!* The bond cap was raised at \$75 per resident or \$225 million, and will benefit state housing finance agencies.

Qualifications-based Selection: *Victory!* Language was included in the TEA-21 legislation to ensure fair selection methods.

Tort Reform: Battle wages on. Addressing liability is becoming more and more of a concern to architects. The AIA will be very active next Congress.

In most battles, we emerged victorious, with some issues to be carried over to the 106th Congress. While there were no casualties regarding AIA priority legislation, having an increased focus on ArchiPAC, more prominent Institute identity, and member-driven advocacy will help solidify the AIA's effectiveness.

GOOD NEWS - BUDGET MEANS MORE MONEY

A series of tense negotiations resulted in Congress passing a \$500 billion budget measure. The agreement yielded concessions by both Republicans and Democrats. While all the numbers are not yet in, many federal construction projects are on the receiving end, which means more projects for architects. The following allocations look promising for AIA members:

- * An emergency spending component that authorizes \$1.8 billion to improve embassy security
- * \$8.4 billion for military construction, \$666 million more than President Clinton's request
- * \$492 million for construction and acquisition projects for GSA, portions of which are designated for courthouse construction, basic repairs and alterations of federal buildings, and individual construction and design projects
- * Approximately 41.7 billion approved for the Department of Transportation program that provides grants for airport improvements


AIAS NEWS

Michael Alcorn, AIA Director, UNLV School of Architecture

Enrollments in the UNLV School of Architecture have surged for the fall semester. The School's FTE enrollment (full-time equivalent students) is 271.6 students up from 200.3 during the fall semester of 1997, a 28.5 percent increase. Enrollments in the graduate M. Arch. program were 714.6% above last year's enrollments with 47 graduate students. Likewise, the enrollments in the Interior Design and Landscape Architecture programs have risen dramatically, with 51 majors enrolled in Interior Design and 29 majors enrolled in the Landscape Architecture programs. There are currently 322 majors enrolled in the programs of the School of Architecture, up from 279 this time last year.

After professional accreditation, enrollment growth is the most important challenge facing the School. The School had projected a goal of 250 full-time equivalent students by year 2002. The fact that this goal has already been exceeded bodes well for building the design programs and establishing higher standards for instruction and student performance. The enrollment growth also will make possible the additions of faculty and staff necessary for the maintenance of an established, mature School of Architecture. Next year the School will add four new full-time, tenure-track faculty members, a model shop supervisor and a computer technician who will be shared with the UNLV Theatre and Art Departments.

One of the missions of the School is to serve as a resource for information regarding the architecture of Las Vegas and Nevada. To this end, Architecture and Librarian Jeanne Brown, is requesting that firms donate sets of drawings for any public buildings and award-winning residential buildings built in the State. These drawings will be held in the special collections area of the library and will be available for students' and scholars' use within the library (not for circulation). If you have materials that you would like to donate to the Architecture Studies Library, please call Jeanne Brown at the Architecture Studies Library 895-4369.

STATE BOARD FIRE SERVICES REPORT

Plan Reviews: The use of contract plan checkers has eliminated the back load. The target is now a 28 day turn-around. But the clock will only start to run when the review fee (NAC 477.750), as well as the documents to be reviewed, have been received. (No Tickee, No Washee!)

Historically, documents for review on an alleged "fast track project" were received will in advance of the review fee with the submitter counting the time from document submittal to fee receipt by the OSFM as part of the elapsed plan review time, despite the fact that the documents were dormant.

When you submit documents for review, ensure that the "Owner" submits the appropriate document review fee concurrently. In fact you might request a copy of their forwarding transmittal for your records. Also, if the plan reviewer needs additional information, e.g. fire sprinkler hydraulic calculations, the review clock will stop running until the additional information is received.

On complicated projects the OSFM will, upon request of the "Owner", meet locally with the "Owner" Architect, Engineers and local fire prevention bureau and building department to resolve any jurisdictional agency conflicts or interpretations.

ADOPTED CODES: The adoption of the 1997 editions of the various codes adopted by NAC 477.281 is underway. Part of the adoption process will be to modify NAC 477.283, Additions to and Deletions from Adopted Codes; concurrently. Any recommendations will be appreciated please send them to me or Bill Petty, PE, the professional engineer member of the board, before November 15th. Our target for revising NAC 477.281 and 477.283 is the December Board Meeting. Until NAC 477.281 is modified, document reviews will be made under the 1997 editions of the currently adopted 1991 codes if the local jurisdiction has adopted the 1997 edition. There is a significant exception - if the 1991 code is more stringent than is the 1997, the OSFM is required to enforce the 1991 edition.

No comprehensive book exists on the architecture of Nevada. But, the Society of Architectural Historians and the



Written by Julie Nicoletta (assistant professor, University of Washington-Tacoma, formerly of the Nevada State Historic Preservation Office, "The Buildings of Nevada" will be the sixth volume in the award-winning, fifty-eight volume series, "Buildings of the United States".

The publication of "The Buildings of Nevada" is important because it will place the architecture of the state into the larger context of American architecture. It will also present the architectural legacy of the entire state by examining diverse building types and contributions by a variety of cultures. It will help educate Nevadans and the broader American public about architecture in the state by identifying both unique and typical building types. With the state's rapid population growth, many significant buildings are in danger of being lost without ever being recorded. In addition, the book will directly encourage heritage tourism, a growing part of Nevada tourism economy. It will aid schools at all levels as a resource for study and teaching, And, it will serve as a companion guide to tourists and local residents traveling through the cities, towns and open areas of Nevada. Clearly written and heavily illustrated with photographs and maps, the guide will make understanding Nevada's architecture entertaining and informative for both the novice and the professional.

With full funding, "The Buildings of Nevada" will be the next volume published in the B.U.S.


