DOUGLAS L. STEIDL, FAIA ELECTED 2005 PRESIDENT

Douglas L. Steidl, FAIA will be the 2004 first vice president/president-elect and will serve in 2005 as AIA president. AIA delegates elected Steidl during a runoff election during the Institute's national convention in San Diego on May 10. Steidl's term as first vice president begins in December 2003.

Steidl is a founding principal of Braun & Steidl, Akron and Columbus, Ohio a general practice firm and recipient of the AIA Ohio's Gold Medal Firm Award. Registered in 21 states, Steidl and his firm provide architectural planning and interior design services for university, medical, religious and commercial projects for which they have won several design awards.

Currently serving as AIA national treasurer, he was a vice president in 2001 and a Board member from 1998-2000, at which time he proposed that the Institute's budget be tied to AIM objectives.

Three AIA National vice president's were also elected and they are Paul Davis Boney, FAIA and CEO of Boney Architects, Wilmington, NC; RK Stewart, FAIA, senior director from the California region and principal with Gensler's San Francisco office; and David H. Watkins, FAIA, founding principal of Watkins Hamilton Ross Architects, Inc., Houston, TX.

James A. Gatsch, FAIA was elected treasurer of AIA. His two-year term will run from 2004-2005. Gatsch is principal of Ford Farewell Mills and Gatsch, Princeton, NJ.

WMR COUNCIL BUSINESS MEETING

The WMR Council met on May 9th, at the San Diego convention and the following resolutions were adopted.

WMR Dues Increase: In order to cover annual increasing expenses, member dues for Western Mountain Region architects and associates were approved to be increased effective in 2004. Architect dues will increase from \$6.00 to \$7.50 and Associate dues will increase from \$3.00 to \$3.75. In Nevada, these dues are included in local membership dues and are paid to the region on behalf of member architects and associates by your local Chapter.

WMR Honor Awards: Changes to the WMR Honor Awards program were approved and adopted. These changes include two new awards -- the WMR Young Architect Award and the 25 Year Award. Watch for the Call for Nominations in June. Also, the Call for Entries for the WMR Design Awards will go out soon. AIA NEVADA PRESIDENT'S MESSAGE

As the State of Nevada enters the last month of the 2003 Legislative Session, continued tracking of the state budget and revenue situation reveals that many unknowns still exist and no

tax plan is clearly prevailing at this time. The Gross Receipts tax is still alive, a professional services 'transaction' tax is still under discussion, sin taxes, Secretary of State fee increases, business activity tax increases and a host of other tax and fee increases are still under consideration. Proposals have been put forth that advocate a multitude of tax increases that combine many of the vehicles previously mentioned, which is of particular concern to the business community.

Many sources state that it is anticipated that the Governor will call a special session to continue the discussion of the state expenditures and revenues to bring resolution to this issue outside of the regular session.

Issues regarding construction defects litigation, liens, the operation of the State Public Works Board, public bidding regulations, and public payment procedures in construction projects are still under discussion, review and redrafting. Progress appears to have been made in these areas, and AIA Nevada's concerns have been heard by the sponsors of the associated Bill Drafts.

AIA Nevada has sent our position statements to most of the legislators and had personal discussions with many officials in state government. As the tax discussion has been the focus of attention, AIA Nevada followed up with updated position statements which were sent to the chairs of the taxation committees in both houses. Your interests as Architects, design professionals and members of the design and construction industry are being represented to state government.

This past May, I was honored to represent AIA Nevada at the 2003 AIA National Convention in San Diego, CA. Elections for national office were held, with Douglas Steidl, FAIA, prevailing for President in 2005. Doug will serve as AIA National President during the 2005 AIA National Convention to be held in Las Vegas. Advance convention planned was conducted as Doug joined the 2005 AIA Las Vegas National Convention Steering Committee for a meeting on May 20, 2003. I am pleased to report that Doug showed great enthusiasm for Las Vegas as host of the 2005 AIA National Convention and showed great leadership, insight and cooperation in discussing the potential for

this convention. I am certain that the State of Nevada will be served well by Doug's leadership in the years to come.

Beyond the active legislative program and the AIA National Convention, the 2003 AIA Nevada Excellence in Design and Distinguished Service Awards is being planned at this time. Reserve the date of October, 11, 2003 for what promises to be an exceptional program. Plans have been made to conduct the event at Caesar's Palace in Las Vegas. I am looking forward to seeing the broad participation of the state membership in this program, which has become a hallmark of AIA Nevada.





CSA tailored the design of this 8,300 sf facility to portray a specific image - Midwest meets the desert. The client requested the facility reflect the images of the Midwest; secure and friendly while responding to the desert climate. Stone and massing of elements were used to convey the feeling of security and permanence while wood was used to add warmth. Passive means of lighting the internal spaces are accomplished with clerestory windows. Deep roof over-hangs provide shade. A light shelf provides a buffer from direct sunlight entering the lobby while shading the west facing entrance.

CENTENNIAL CORPORATE CENTER



This five story Class A office building and retail center will be a first for the growing Centennial Hills area of Las Vegas. Located at the highly visible intersection of Ann Road and US95, the building design is distinctive, with an uplift crown that becomes an identity element and theme for the entire site development. The building materials are texturized stone veneer at the human scale, and smooth metal panels on the levels above. The highly upgraded lobby is modern in design, but captures a traditional richness through marble and limestone flooring, and deep mahogany paneling. Site massing is scaled to transition from five stories to the surrounding residential neighborhood, and a neutral desert palette was chosen to blend with the environment. Site amenities are geared toward building users, as well as neighborhood residents and visitors to the adjacent golf course, and include a single story retail center with outdoor cafes and food court. The retail center materials match those of the office building, but to a lesser scale, with the use of stone and metal accents. Highly upgraded landscaping minimizes the impact of surface parking for 258 vehicles and a three level parking structure for 309 vehicles.

The 79th President of the American Institute of Architects, Thompson E. Penney, FAIA will be the special guest speaker at our AIA LV June Membership Meeting. This will mark the first visit to Nevada by an AIA National President since 1993. Mr. Penney will speak on "Connecting the Dots Between Design, Predictive Knowledge and Public Advocacy", addressing today's changing social and cultural environment wherein "we have the opportunity, unique in our professional lives, to reach out, to make the connection in the public's mind between their growing hunger for value, and what we architects do." He calls upon architects to think about a profession that is based on empathy and caring, one that has the power to provide design solutions that have a greater value and a deeper purpose. "We have an opportunity, and I would say a responsibility" to offer proof about how design enriches life."

Thom is the president and CEO of LS3P Associates, Ltd., an architecture, landscape architecture and interior architecture firm with offices in Charleston, S.C. and Charlotte, N.C. In addition to his strong interest in design, Thom is equally interested in the business of the profession. LS3P, under his leadership has grown to become a regional firm recognized by ENR as one of the top 500 design firms in the United States. He has served the AIA in numerous leadership roles at all component levels, including terms as president of AIA Charleston (1981) and AIA South Carolina (1994). He currently is chair of the National AIA/AGC Joint Committee, a member of the AIM Advisory group, delegate to the 2002 UIA World Congress and Assembly, and a member of the Board of Regents of the American Architectural Foundation. He has also served as director of the South Atlantic region (1998-2001), chair of Grassroots 2002, and chair of the Institute Honors for Collaborative Achievement jury.

2003 AIA NEVADA EXCELLENCE IN DESIGN AND DISTINGUISHED SERVICE AWARDS

June 1st marks the launch date for this year's AIA Nevada Excellence In Design and Distinguished Service Awards programs. Watch you e-mail, the AIA Las Vegas website (aialasvegas.org) and your snail mail for the Call for Entries and the Call for Nominations.

The 2003 Excellence In Design Program is open to all AIA members who are licensed in the state of Nevada for projects located anywhere in the world, and also, to AIA members from other states who are licensed in Nevada for projects located in Nevada. Categories include:

Built - *Building projects that are complete.*

Un-built - *Commissioned projects that are currently under construction or complete through schematic design.*

(Note, projects that have received awards previously in the Unbuilt Category and have since been completed, may be entered in the built Category, provided they were completed since January 1, 1999.)

Interior Environments - *Completed Interior Projects*

Urban Design - *Urban design projects completed or currently under construction. Must be of a designed urban environment or urban element displaying multiple design disciplines.*

Open - *Self-initiated or uncommissioned projects, theoretical or research projects. May be a non-building designed item, element, concept, object or idea that is based on exemplary design. This category encourages the submittal of designed "things" and may range from a project to jewelry to furniture to a web site.*

Student Projects - *Academic projects that are created by students participating in a college or university program of architecture, for academic credit during the current academic year 2002-2003. Students must be members of AIA or AIAS.*

Entries will be judged individually, not in competition with each other. Equal emphasis will be given to all submissions in the identified categories. Jurors will be instructed to consider the following.

Contextualism/Regional Response - Does the project relate to its surroundings? Is the project an appropriate response for the surroundings?

Environmental Response - Does the project promote environmental awareness conciseness? What significant impact does the project have on the

Program Response - Does the project respond to the needs of the user? What significant elements or uses set this project apart from others? This could include specialty needs/features of the project, budget constraints, highly specialized program/use. Does the project really do what its supposed to do?

Comprehensive Design - Is the project consistent good design throughout? Exterior? Interior? Landscape? Lighting?, etc?

Design Excellence is the final standard upon which all entries will be judged. Project authorship will be concealed throughout the judging and jury process.

Call for Entries closes on Wednesday, September 10, 2003. Deadline for Submission Binders is September 26th; and award recipients will be announced at the 2003 AIA Nevada Excellence In Design Banquet and Awards Ceremony being held on Saturday, October 11th, at Caesar's Palace in Las Vegas.

2003 AIA NEVADA DISTINGUISHED SERVICE AWARDS

Each year AIA Nevada honors the achievements of exceptional AIA members and firms through the AIA Nevada Distinguished Service Awards program. The awards are designed to recognize the significant contributions made to the community and the profession through the various levels of AIA membership. This year, recipients will be honored at the AIA Nevada Awards Banquet and Presentation Ceremony being held at Caesars Palace Hotel & Casino on Saturday, October 11th, 2003. Categories include:

The Silver Medal - the highest honor the state can bestow upon a member and is awarded in recognition of the most distinguished service to the profession of architecture.

The Architecture Firm Award - is awarded to the firm that has consistently produced distinguished architecture for a period of at least ten years. The jury will focus on the quality of the firm's architecture, commitment to the AIA and service to the public. (Please note - this is NOT a "Firm of the Year" Award, since it is based on a distinguished record of quality design and service for a period of ten years or more.)

The Nevada Service Award - is awarded to the individual member who has contributed significantly to the profession of architecture through the American Institute of Architects.

The AIA Nevada Patron Award - recognizes the critical role of clients, elected officials, public administrators and community leaders who contribute to the development of laws, regulations, policies or architecture that affects the process and the creation of quality built environments as well as the public perception of architecture and its importance.

The Young Architect Citation - is awarded to individuals who at an early stage of their architectural career, have shown exceptional leadership in design, education and/or service to the profession.

The AIA Nevada Associate Award - is awarded to the individual Associate member who has contributed significantly to the profession of architecture through their membership and participation in their local Chapter of the AIA.

The AIA Nevada Allied Member Award - is awarded to the individual Allied member who has contributed significantly to the profession of architecture through their membership and participation in their local Chapter of the AIA.

To place a name in nomination for an award, please verify that the person/firm you nominate will accept the nomination and that they are willing to provide the required submissions binder and materials. Complete the nomination form (found on the aianeveda.org website or in your mail).

Nominations close on Friday, July 18th, 2003. Submission binders must be received at the AIA Nevada office by noon on Monday, August 18th, 2003. (No Exceptions).


