



THE RURAL STUDIO NOVEMBER MEMBERSHIP MEETING NEW MEETING DATE - TUESDAY, NOVEMBER 11TH

As a part of our "Sustainable Nevada" lecture series, the AIA Meeting for November will feature a special showing of the PBS documentary "The Rural Studio". The hour-long documentary celebrates MacArthur Fellow Samuel Mockbee's vision of architecture as a catalyst for social change. The film follows his student architects of Auburn University as they help to rebuild the social and physical landscape of a long neglected rural community "brick by recycled brick".

Produced and directed by Charles Schultz, the film beautifully captures Sam Mockbee's gifts both as an architect and as a teacher. As Mockbee and his students work with black and white families in Alabama, they present the viewers with a powerful architectural vision. It is a vision that challenges architects to build exciting housing that is accessible to all our society.

Schultz was inspired to document the Rural Studio's work and Mockbee's abstract vision after they met in 1997. Mockbee's ability to inspire a unique school of architecture that built a series of homes and community structures for impoverished citizens will be forever documented. Schultz stated, "Sam had that rare quality to lead while simultaneously elevating those he supervised. Using architecture, he helped develop relationships between his students and members of the community which have continued after the construction of the buildings ceased. He succeeded in creating real human bonds among disparate groups."

In addition, our own Lance Kirk, Assoc. AIA, and recipient of this year's AIA Las Vegas Intern Travel Award, spent a week at the Rural Studio in September, and will provide a brief presentation of his first-hand experiences in working with Samuel Mockbee and observing the accomplishments of the Studio.

It is the highest award the AIA gives to an architectural firm, and is awarded to firms that produce distinguished designs for at least 10 years.

The Miller | Hull Partnership strives to make a significant contribution to a richer modernism. Since its inception, the firm has pursued a rigorous logic in its design process aimed at exploration of regional influences on modernist forms. The success of this exploration can be seen in the influence that Miller | Hull Partnership has had, and continues to have, on architectural design in throughout the United States. The design philosophy of Miller | Hull Partnership centers around two essential architectural ideas. One is to use a building's structure and program to create a significant place within a site, and the other is to be sensitive to climate and to respond to environmental demands with the form of the building. These ideas have allowed Miller | Hull Partnership's projects to convey a harmonious balance between form and nature.







We are also working with the AIA 2005 Conference Steering Committee and look forward to defining our activities for the week of the conference.



2003-04 AIA LV HIGH SCHOOL DESIGN CHALLENGE

Want to be a part of an important and interesting AIA program....and assist talented young designers in getting started? Become an advisor to one of the high school classes that will be participating in this year's High School Design Awards program. Wade Simpson, AIA is Chair of the committee. Give him a call if you'd like to be a part of it - 435-1150.

This year's program challenges students to use their creativity, their design skills and their drafting knowledge to create a "mixed use" project.

The Challenge: Your new client owns a piece of property in downtown Las Vegas. The client wants to create a "mixed use" project that has commercial space on the ground level and a residence for his family on the upper floor(s). You are to design the full residencebut you only need to design the commercial space as "shell space" ready for future "tenant improvements."

Residential - The home is to have a living room, family room, or a combination living/family room, 3 bedrooms, 2 bathrooms, a kitchen, dining area, at least one large patio/balcony with spa, etc. The home is not to be over 2500 square feet in area. There should also be a 25' x 25' garage connected to the house via an inside stairway. There should be an inviting means of entry to the home from the exterior, although it should be distinct and not detract from the viability or attractiveness of the commercial space.

Commercial - The commercial space should be 3000 square feet in area. It should have prominent exposure to the streets. Its access is to be visible from the street. It doesn't have to be a big square space.

The property is at the southwest corner of Bonneville and 4th Street. It is 50' x 140'. It is surrounded on the street sides by a 5' wide sidewalk. There is a 7' landscape strip between the sidewalk and Bonneville. There are no setbacks for your building, but windows and doors must be at least 5' from the west and south property lines. There is a 20' wide alley to the west of the property. The height of what you will propose will be limited to 40'. Multiple levels are required to include all the required square footage. Your design should respond to the city and desert surroundings and the solar exposure.

Full details of the design challenge and the submittal requirements are available through the AIA office or from Wade Simpson, AIA.

Students will work on the challenge from now until April 2004, when their work will be juried. The AIA High School Design Awards program will be held on Wednesday, April 21st, at the Gold Coast Hotel 2nd Floor Ballroom.
