
The conference will be held October 21st - 23rd at the Salt Palace, with the downtown Marriott Hotel serving as the host facility.

Continuing Education: Where do you stand?

With the advent of continuing education requirements in numerous states for licensing, it is only a matter of time before this will be a requirement in Nevada. What do you think? Should Nevada require continuing education as a requirement of license renewal? I think so. AIA has required continuing education for membership. I know that CE's have been looked at as a hassle from a lot of members across the country. The initial negative response for AIA was going to be a drop in membership. Now we are larger and healthier as an organization than ever. States that have requirements for CE's are finding that the quality of professionals has been enhanced.

NSBAIDRD OFFERS TOWN HALL MEETINGS

You are invited to share your concerns and discuss other topics as the NSBAIDRD prepares for the 2005 Legislative Session. Two Town Hall meetings are scheduled to discuss topics of importance that are under consideration by the board. These include:

* **Registered Interior Designer Education Requirements** - The board will listen to suggestions to amend NRS 623.192.1 to allow applicants with degrees from programs not accredited by FIDER to plug gaps in their education with experience. This will be especially useful for interior designers who have been practicing for many years and may have earned their interior degrees before FIDER was well-established.

* **Registered Interior Designers' Ability To Collaborate With Other Design Professionals** - The board will listen to suggestions to amend NRS 623.354 to remove the current restriction that limits registered interior designers from collaborating with more than two other design professionals. The board will also discuss what other language may be necessary to ensure that this change will not permit registered interior designers to work outside their scope of practice.

AIA NEVADA PRESIDENT'S MESSAGE

Architects today are faced with the uneasy task of looking forward in a time of

unpredictable progress toward a new standard, while the lure of nostalgia keeps propelling us back into the past. At the cusp of the 21st century, we find ourselves torn between new realities we do not yet fully understand and old convictions and ideologies that ensure certainty and refuge in a world where they are disappearing.

In a recent design review session with a University, I was asked why we were not pursuing a "Jeffersonian" style for a sports training and office facility remodel and expansion. Although there are a number of examples of these classical pieces on campus, the athletic department is pushing for a contemporary facility that is as much unique image to identify the athletics program as a recruiting tool to 17 year old high school kids. The University is looking in the direction of tradition and standards for returning the campus to its root's of the early 1900's.

Glass curtain walls meet limestone columns, i.e. Soldier Field. Such disorder can be destructive, but certainty can also occur at the edge of chaos. This escalating connection that defines our era is most obvious in rapidly increasing media, communications and information networks. In the way that the scale, order and proportion were intrinsic to Jefferson, the nonlinear decentralized open and complex are twisted together to form a new architectural logic of today.

So as we continue down this new path, one of the greatest challenges for architects is to create structures and systems that can adapt to constantly changing sites of emergence. With new technologies to fuel the imagination and the availability products that did not even exist 10 years ago, architecture is continually expanding the realm of what's possible.


The call for entries and nominations has been sent out to all AIA members in the Western Mountain Region for the 2004 WMR Design and Honor Awards.

DESERT STRUCTURES

Dr. Robert A. Fielden, A. D., NCARB, FAIA



If you're new to the Mojave Desert, you'll soon recognize that living here is unlike living anywhere else in America. This is a hostile environment, its always dry, it gets extremely hot and we receive some of the highest solar exposure on the planet. With the exception of housing, where solar exposure on the east can gently warm our winter mornings, and keep our homes with southerly exposures warm on winter days, its in our best interest to keep sunlight entirely off our buildings. Instead of transporting Orange County designs to Southern Nevada, where tile roofs collect and store heat all day and over-radiate our buildings, we should be adopting design models, evolved from the Middle East centuries ago, that are all about creating shade.

More than 60% of our solar gain is attributable to the roof. So if we keep sun off the roof, we'll reduce power bills dramatically – and significantly extend the life-cycle of roofing systems. There are many ways to do this; with our postage stamp building lots, we can move our shaded patio to the top of the house or office building. Another technique is to install a thin, perforated, reflective layer of material over the roof, with about an eight-inch air gap between the material and the roofing – leaving the edges or eaves open for natural ventilation.

Previously, I talked about free lighting during the day, free water heating and using trees to create shade and lower ambient temperatures – so I'm excluding those considerations from my comments today. But don't forget the values of day-lighting, skylights, solar heating, trees and landscaping - in terms of eliminating significant demands for energy year around.

I want to talk to you now about space, windows and walls. High volumes are extremely valuable for minimizing air-conditioning when natural ventilation is possible. Even with the largest buildings, natural ventilation can be extremely effective reducing requirements for energy – using filtered outside air for cooling or tempering the indoors. Heat naturally rises, so we bring cool outside air into a room near the floor and exhaust the air near the ceiling. Double-hung windows are specially designed for this purpose. If there is an attic space, exhaust air can be ventilated through it as well.

Keeping the sun off of windows and walls is accomplished using screens: the way screen walls are used in the Middle East, or by creating large overhangs like those used with porches in the south. Here in the desert, masonry is an ideal material for constructing interior and exterior walls – because the mass of the masonry can be used to store temperature. When constructing exterior walls, the building insulation should be installed on the exterior wall face and then covered with a finish material. Roofing insulation should be installed similarly. By moving insulation to the exterior, we keep outdoor temperatures from penetrating into the building.

Masonry walls can be located strategically to slowly transfer stored temperature back into interior space for either heating or cooling. During those parts of the year when heating is necessary, the masonry can store and transfer solar heat; when cooling is required we flush the building at night, storing cooler temperatures for transferring during the day.

Structures built in this manner will not only serve us well, significantly reducing society's demands on energy by more than 50%, but they will serve our communities and America in a sustainable manner for hundreds of years in the future.





National Award Recognizes Contributions to Accessible Design






"Jack 'Can' A Box," by Mackey Mitchell Associates, St. Louis



BUCKMINSTER FULLER: YET ANOTHER STAMP ON THE PLANET


USPS HONORS ARCHITECT AND INVENTOR

Fifty years after R. Buckminster Fuller, FAIA patented his Geodesic dome, the U.S. Postal Service has issued a commemorative stamp honoring the brilliant American inventor, philosopher, architect, and engineer. Released on July 12, the stamp features the Boris Artzybasheff painting of "Bucky" with his head in the pattern of a Geodesic dome that originally appeared on the cover of *Time* magazine on January 10, 1964. Also depicted in the painting are a number of his other inventions, most notably the Dymaxion Car and the 4D House.

On July 12, 1895, Fuller was born into a Milton, Mass., family noted for its individualists and dedication to public service. During family trips to Bear Island, Maine, Fuller learned the principles of boat construction and maintenance and developed an understanding and appreciation of nature. During service in the U.S. Navy, Fuller invented a winch that could pull airplanes out of the ocean quickly enough to save the crew's lives. As a result of his engineering feat, Fuller was admitted to the U.S. Naval Academy, where he further developed his capabilities. Fuller earned his first of 25 patents with his father-in-law, James Monroe Hewlett. Together they developed a new way of manufacturing reinforced concrete buildings.

Fuller's lifelong goal was the development of a "Comprehensive Anticipatory Design Science"—an attempt to anticipate and solve humanity's problems through technology and using fewer resources. Among his designs were the Dymaxion House, an inexpensive, mass-produced home that could be airlifted to its location; the Dymaxion Car, a streamlined, three-wheeled vehicle that could make extraordinarily sharp turns; and a compact, easily installed Dymaxion Bathroom. Coined by store advertisers and trademarked in Fuller's name, the word "dymaxion" was employed in a number of his inventions and was a fusion of the words "dynamic," "maximum," and "ion." In 1946, Fuller patented the Dymaxion Map—a flat map that depicted the entire planet without visible distortion of the relative shapes and sizes of the continents.

After 1947, the Geodesic dome dominated Fuller's life and career. Lightweight, cost-effective, and easy to assemble, Geodesic domes enclose more space without intrusive supporting columns than any other structure. In addition, they efficiently distribute stress and can withstand harsh external conditions. Based on "synergetic geometry," the Geodesic dome was the result of Fuller's revolutionary discoveries about balancing compression and tension forces in building.



After being spurned early in his career by the architecture and design professions, Fuller was later recognized with many major architectural, scientific, industrial, and design awards, including the AIA Gold Medal in 1970. In 1983, he received the Presidential Medal of Freedom, the United States' highest civilian honor. Fuller died on July 1, 1983.

The ceremony celebrating the release of the Buckminster Fuller stamp was held at Stanford University, where his papers are archived. In attendance were Fuller's daughter, Allegra Fuller Snyder, professor emerita, dance and dance ethnology, UCLA; Buzz Aldrin, astronaut, Gemini 12 and Apollo 11; Joshua Arnow, president, board of directors, the Buckminster Fuller Institute; Michael A. Keller, university librarian, Stanford University; and Anita Bizzotto, senior vice president and chief marketing officer, U.S. Postal Service.


