Looking forward.....we see an exciting future for the AIA Las Vegas Chapter, its members and the Las Vegas community.

Plans for AIA 150, and the production of the Blueprint for Las Vegas provides an excellent opportunity for the Chapter and members to make a real contribution to the future of our city. The 24-Hour Town Hall Meeting, (April 13-14) the highlight of Architecture Week, will allow AIA member architects and design professionals to work with community leaders to produce a realistic "blueprint" for making Las Vegas a more sustainable and livable community. In February, members of the AIA LV Board of Directors, led by President Curt Carlson, explored the future a little further in order to devise a strategic plan for the Chapter. Working together in the day-long session, they determined a new mission statement and agreed upon the core values of the Chapter. Then based on these they worked to clearly define the goals, opportunities and challenges that would take the Chapter through the next three to five years. On March 21st, the new Strategic Plan will be presented to the membership. This look into the future will be held at the World Market Center, an appropriate location since it is an exciting example of the future of Las Vegas.



In 2008, AIA Las Vegas will expand our reach and our visibility in the community by establishing more public offices in the newly revitalized Fifth Street School. Located on Las Vegas Boulevard directly across from the Federal Courthouse, the new location provides expanded meeting and lecture space, gallery and exhibit space and an opportunity to partner with the Nevada School for the Arts, the UNLV School of Architecture downtown studio and the City of Las Vegas Cultural Affairs Division. We will maintain our offices on campus in the UNLV School of Architecture as well, in order to continue to provide the vital link between the students, the school and the professional community.

The future of AIA Las Vegas looks great, filled with promise and possibility. Be a part of it.

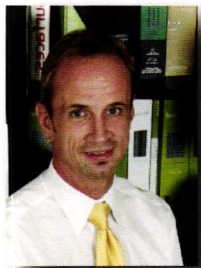


## AIA LAS VEGAS PRESIDENT'S MESSAGE

### What have you done for me lately?

Last month I had the opportunity to have lunch with eight of the Western Mountain Region's Component Executives (CACE, Council of Architectural Component Executives.) One of the first questions they asked me was "What do I get out of the AIA?" That started me thinking about a couple of additional issues: "Why am I in the AIA and What am I doing in the AIA?" If anyone had asked me 26 years ago (when I graduated from school), I'm sure I would have had a different set of answers. I was never a member of AIA in school, but I joined the AIA as soon as I started working because I thought it was the thing a young intern was supposed to do. For the past twelve years I have served on the Las Vegas board and now find myself President of the chapter.



Why am I in the AIA? At first I think I saw it as a way to be identified with a nationally recognized professional organization (and a way to put some initials after my name). Now I see myself as a member because of the opportunities it offers me. It is a way to keep in touch with other areas of the profession: locally, regionally and nationally. It is a way to keep current on continuing education and let's face it, it's a way to promote yourself within the profession.

What am I doing in the AIA? That seems to be a question I ask myself a lot. I hope the answer is 'affecting change'. I am as guilty as the next person in pointing out the shortcomings of this organization, but I have realized it's not going to change unless someone does something about it.

1. Students aren't involved in the profession and the profession isn't involved with the students – so sponsor an AIA meeting, jury for the school of Architecture, hire an intern from the school, or sit on an advisory committee.
2. The public is unaware of what the profession does. There is a lot we can do. So, promote programs that highlight the profession and look for opportunities to get architects involved in community projects. The AIA 150 is a great opportunity.
3. Some say the AIA is a social club that gets together once a month for cocktails. Any organization is what its members make it. Setting and implementing a new strategic plan with goals for the chapter is a way of making sure the AIA gets things done and we are currently doing just that.

What do I get out of the AIA? This one gets easier to answer the more involved I get in the organization.

1. Last week I was in Washington DC for Grassroots. Through this, I had our annual meet and greet breakfast with one of the most powerful men in the country - Senator Harry Reid. I also got to meet with Representatives Berkley and Heller. When I got back to Las Vegas, Congressman Porter called me to apologize for not being available for our meeting. (Ensign was out sick)
2. I have had dinner (cocktails) with Mayor Goodman.
3. I have shared the podium with Shelley Berkley, Mayor Goodman, and had to speak to audiences of over 500 people.
4. I have been on the radio as a guest speaker for architectural programs and talk shows.
5. I have represented the chapter at the national conventions here in Las Vegas, Los Angeles and the upcoming one in San Antonio.
6. I have represented the chapter at regional meetings in Salt Lake City, Wyoming and Washington DC.
7. I am writing for a national publication - Architecture Las Vegas magazine.
8. I have had clients include me on their development teams because they could introduce me as the President of the AIA in Las Vegas and they thought it added credibility to their projects.

And the list goes on. This is just the beginning of the things I get to do because of the AIA. If I weren't involved in the AIA, I wouldn't have these opportunities.

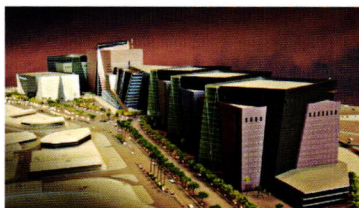

## AIA LV SPRING PUTTING TOURNAMENT

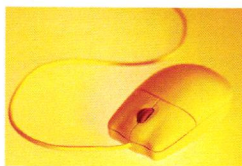

Due to space limitations, RSVP's are required. Please call 702.822.6536 no later than April 2nd. Parking will be available behind the Senior Citizen's Center.



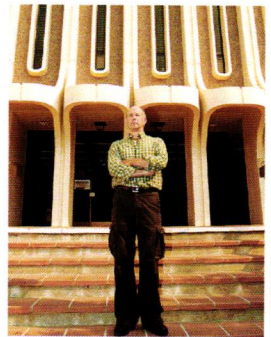

Beginning at 2PM on Friday, April 13th at Rancho High School, the opening session with an introductory session will frame of the scope of the objective.

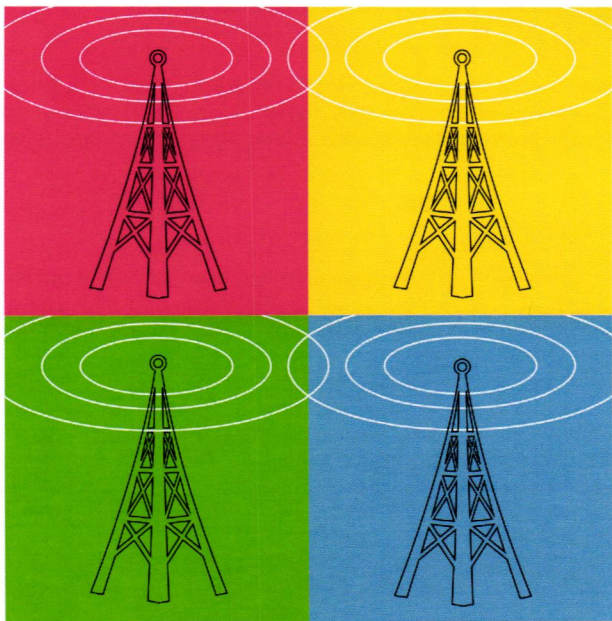

Two City of Las Vegas Building and Safety employees have recently been appointed to regional and national boards.

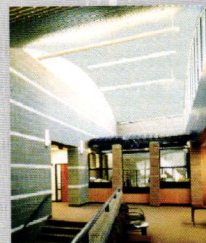

## AIA 150 CELEBRATION – 24-HOUR TOWN HALL MEETING

The local Las Vegas chapter of the AIA has chosen to conduct a 24 hour Town Hall Meeting / Design Charrette, based on the core objectives of the "Blue Print for America" initiative, in support of the AIA 150 nation wide celebration.

This is a unique opportunity to collaborate with a diverse and creative group of local community members to help identify local livable community issues, develop and elaborate on potential solutions to the issues, and present those findings to a prominent group of local leaders and decision makers.

The subject and focus of the 24 hour Town Hall Meeting will be on how to make Las Vegas a more livable community. The participants will each be divided into one of 8 focus groups of their choice to charrette on the key elements that drive our community and help determine how to improve it. Exchanging ideas and collaboration between groups is encouraged. The final outcome of this meeting will be presented to a group of select panelists for comment and feedback at the end of the 24 hour session. The results of this 24 hour "ideas" session will be later memorialized in a "Blueprint for Nevada" document (one section for Reno and one section for Las Vegas) which will be presented to the Governor and/or public officials at the end of 2007.

The 24 hour Town Hall Meeting, lead by local AIA members, is open to all members of the community.

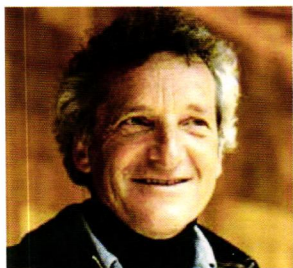

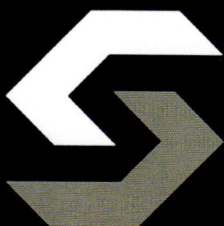

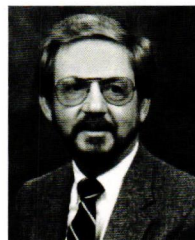

### VIEW FROM CARSON CITY

The first two weeks of that biennial Carson City gathering known as the Nevada State Legislature are in the books – two weeks of drugs, roads, education, budgets, and a forthcoming presidential forum. And, as always, questions, questions, and more questions.

The 74th Regular Session of the Nevada Legislature got off to a historic start with only a minor hiccup. Assemblywoman Barbara Buckley (D-Las Vegas) was elected the first female Speaker of the Assembly by a unanimous, er, almost unanimous vote on opening day. The by now infamous lone "nay" vote came from freshman Assemblyman Ty Cobb (R-Reno) who took quite a beating from Democrats and Republicans alike, though his action seems to have re-energized the ultra-conservative base.

Next up, a clarion call to tackle head-on the overwhelmingly complex and socially debilitating issue of methamphetamine – its use, production, and proliferation. There seems little question the state will do something – the question is what.

The balance of Week One was consumed by various budget hearings, informational presentations, and, somewhat uncharacteristically, the introduction of nearly 100 pieces of legislation. Many veteran lawmakers and lobbyists alike were heard to comment on this session's fast start thanks to more pre-filed bills than ever – a measure designed to "jump start" the law-making process. To many long time observers, the pace was more mid-session form, with several bills being heard during each committee hearing.

Of particular note was a presentation from the Governor's Blue ribbon Task Force on Transportation – no, not this governor, the other (former) one. In presentations to the combined taxation committees and later to the joint transportation committees, the Task Force outlined the \$3.8 billion dollar transportation infrastructure needs facing the state right now. Against the backdrop of Governor Gibbons "no new taxes" pledge, legislators were puzzled over how to generate the necessary revenue to address the issue, leading some lawmakers to call for sending a transportation tax measure to a vote of the people. This prompted the sounding of an alarm by one of the Task Force members, a long-time transportation consultant, who emphasized the average start-to-finish time of a major road construction project is about 10 years – "and we're already 10 years behind." By the end of the second week other lawmakers were not content to wait to let the voters decide, and were devising plans to act now.

Week Two began as "Education Week" with a presentation by the state's school superintendents on their billion-dollar iNVEST plan to improve schools. That was followed by a Democrat press conference announcing their education plan and pushing back against the governor's education plan. Democrats again emphasized their support for full day kindergarten, performance pay for teachers, and teacher incentives. Democrats and superintendents both criticized the governor's empowerment plan primarily because its funding source strips money from existing teacher incentive programs. The governor responded that he was only reacting to what school superintendents had described to him as an ineffective incentive program. And that was just Monday!

Here's a first: the coming week will see a Presidential Forum come to Carson City headlined by United States Senator Hillary Clinton (D-NY). The event stems from Nevada winning the right to host an early presidential caucus and is the first of what political party patrons hope will be many. A notable exception from the forum is Senator Barack Obama (D-IL) who declined to participate in the forum next week, but is scheduled to make a stop in Las Vegas a couple of days before the February 21st event in Carson City.

As for the legislative session, while the next few days may seem "slow" the echo can be heard of a steady drumbeat of hearings and debates on legislation, on policy, on programs, and, of course, on money as we begin down the bumpy road towards the 120th day – June 4th.

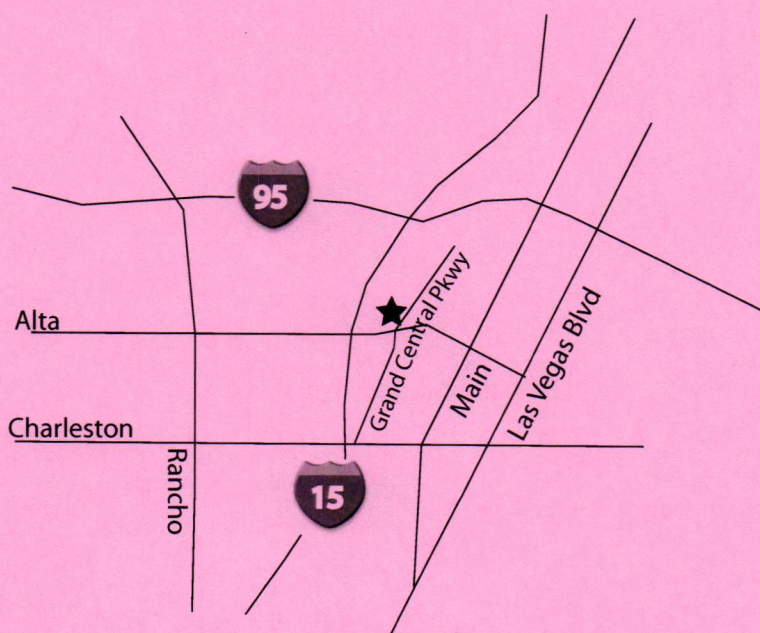

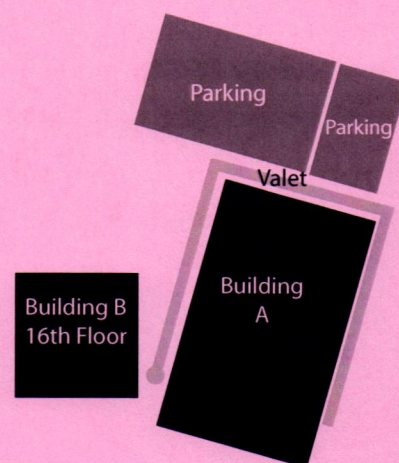

## AIA NEVADA PRESIDENT'S MESSAGE WADE SIMPSON, AIA

### Grassroots

Last month Randy Lavigne, Curt Carlson, Mark Hobaica, David Frommer, Larry Macias and myself represented our state at AIA Grassroots Legislative and Leadership Conference in Washington, DC.

The conference began with a general session set up to prepare the 850 attendees for our meetings with our representatives at the capitol on February 8. The majority of discussion focused on sustainability issues.

RK Stewart stated that we are at "The Tipping Point" with regard to sustainability and our relationships with our representatives. We need to "Build Bridges" with our legislatures he said. He spoke about the idea of sustainability being more than just architecture, since buildings account for 48% of the energy use of our nation.

The issues we took to Capitol Hill this year were to serve the public good, not lobbying for special interests.

The Three major issues we took to our representatives (and we met with all 5) were:

1. Request for energy efficient federal buildings.
2. HR 539, support to increase and extend tax incentives for private development to be energy savers.
3. HR 720, support to include green aspects in the clean water act.

There have been other newsletter articles giving you the details on these three issues. I want to tell you that when we spoke to our representatives and their aides they look at you with a question of "so what is in it for you or why do you care about that so much?" It is wonderful to explain the value to our profession as the same value our communities get from such actions.

Some interesting statistics presented include:

1. The United States uses 25% of the world's energy for 4% of the world's population.
2. 9% of the global CO2 emissions come from United States buildings.

There were two representatives speaking on other issues. Congressman English from Pennsylvania spoke on the "Community Revitalization Act" and Congresswoman Velasquez from New York spoke on the Small Business Agenda and tax packages. There may be some small business tax relief in conjunction with the minimum wage bill.

Randy was very active at this Grassroots. She was interviewed by AIA Architect regarding the plans for Nevada's AIA150 celebration. She also presented the Candidates Forum we held last year and the AIA150 plans in a seminar regarding sustainable communities.

Even though the weather was "Freeze your Face" cold we did receive a "Warm Sustainable Welcome" in Washington from the national AIA and from all of our states representatives.

## HOW DO I REINSTATE MY MEMBERSHIP IF I LAPSE DUE TO CES NON-COMPLIANCE?

The AIA/CES Reinstatement Policy allows members who have been lapsed for non-compliance to reinstate at any time. Those applying to be reinstated must report 9 previously unreported LU hours in addition to their annual 18 LU hour (8 HSW) requirement. The 9 LU hours above the usual yearly number must have been completed within one year of the date of applying for reinstatement. The Reinstatement Form must be completed for reinstatement consideration.
