Outside of work, I enjoy writing about architecture. I recently finished an article about rendering that was published in PLAT, Rice University's architectural journal.

**What is the most important thing you've learned?** Ctrl+S often.

**What is your favorite piece of architecture? Why?** Villa Arpel from the film Mon Oncle – it's a reminder to architects to not take themselves too seriously. To prove my point, my second favorite piece of architecture is Pruitt-Igoe.

**What person, living or dead, would you most like to talk with?** I would have an open discussion with Giovanni Battista Piranesi, Marcel Duchamp, David Bowie, and Sylvia Lavin – just to see what would happen. David Bowie if I had to pick one.

**AIA Las Vegas  
President's Message**

I just returned from the Western Mountain Region (WMR) Conference held in Salt Lake City last week. We had a great delegation from Las Vegas and Northern Nevada. The WMR includes (6) states – Colorado, Wyoming, New Mexico, Utah, Arizona and Nevada and represents a massive geographical area. This region is unique because of the variety of the geography we have the opportunity to work with... from the hot, dry Mojave Desert to the grand beauty of the Tetons. We also work on projects where the animals outnumber the humans – I went to Stephen Dynia's presentation at WMR and a program requirement for one of his houses required a "moose trough" – were you aware that there is a certain height required to pull this off correctly? We also have growing thriving cities such as Denver, Phoenix, and Las Vegas in our region that provide challenging and creative opportunities for us.

A group of us were fortunate to have dinner with Russell Davidson, FAIA, our current AIA National President. One of our conversations centered around the subject of the recruitment of youth in our profession. This is not a new subject, but it is worth bringing up again. There are statistics that predict we will have an incredible shortage of approximately 25,000 Architects in the next 10 to 15 years. This gap will continue to increase unless we are proactive. Russell is leading a national AIA K through 12 initiatives focused on reaching out to the schools in our region. The AIA can be very impressionable by spending time with young students to excite and entice them about our profession. As we are all aware the early years are so impressionable. I was recently thinking about how the Sports world has been focused on youth for years and identifying early talents... so why shouldn't we?!!!

Our High Schools in Nevada were forced to drop programs and classes focused on Architecture and design during the economic downturn. However there is a group within our Board and Chapter that have been making a concerted effort to address this subject. This is another great example of how the AIA can make positive impacts within the profession and on our community.

Note that in 2017 (next year) the WMR Conference returns to Nevada in October and we will host it in Las Vegas. Jennifer Turchin, AIA is chairing the event and she and the conference committee are putting together plans for a great conference.

Congratulations to Mark Ryan (currently serving as Nevada AIA's President) who was unanimously elected as the Treasurer for WMR Council for 2017 and 2018. This is an important position and it keeps our Chapter involved in the Region at the Board level.

Rounding out the year we have some great events and meetings coming up:

- Oct. 19th is the AIA Product Show being held at the 5th Street School – please plan on attending and supporting our vendors and suppliers!

## NOVEMBER MEMBER MEETING 1986-2001 – THE FASTEST GROWING CITY IN THE COUNTRY



The period from 1986 to 2001 was an era when Las Vegas was recognized as the Fastest Growing City in the Country. With an average of 4 – 5,000 new residents each month, the Las Vegas valley was filling up and new residents were demanding bigger homes, better transportation, schools, churches, shopping centers, strong infrastructure and much more. The population grew from around 600,000 in 1986 to over 1.4 million by 2001. And the number of visitors to our city more than doubled in that fifteen year period, going from 16 million to over 35 million.

The architects who were working in Las Vegas during this period were involved with some of the most innovative and exciting projects ever created. The Strip was alive with activity and this period is known as the most constructive decade in Las Vegas history. It includes the construction of Bally's, Excalibar, Mandalay Bay, Four Seasons, Harrah's Las Vegas, the Luxor, New York, New York, The Mirage, The Monte Carlo, The Paris, Treasure Island and the Stratosphere Tower. In addition Las Vegas architects designed and built 123 Elementary, Middle and High Schools in the Las Vegas Valley. That's an average of 8 schools a year for a fifteen year period, making Clark County School District one of the largest in the country.

**LIEN LAWS IN AMERICA**  
 ERIC ROBERTS, AIA  
 SGN REPRESENTATIVE

In the 2017 AIA Legislative Session, AIA Nevada will be working for you. AIA Nevada is leading an effort to revise language in NRS 108 during the 2017 legislature that will clarify and level the playing field for architects and other providers of design services in priority disputes. Our legislative committee and representatives from ACEC, ASLA and other affiliated organizations will be seeking to develop revisions that clarify lien positions for

designers, and help lenders understand pre-existing encumbrances that may exist on a property prior to executing a deed of trust.

According to the current NRS 108, architects and design professionals are placed in a disadvantageous position with regards to protection from the law in lawsuits that arise from client non-payment due to projects not being completed. Architects have limited protection from statutory mechanic's liens because the Nevada Supreme Court has historically (and continues) protecting the priority of lender's deeds of trust if no actual construction at the project begins.

In 2011, the Nevada Supreme Court affirmed its holding that NRS 108 protects lenders rights first against mechanic's liens recorded by architects and design professionals in spite of specific first-hand knowledge of design work done and a mechanic lien perfected prior to a deed of trust. The ruling in J.E. Dunn Northwest v. Corus Construction, affirms a 30-year-old rule and actually expands the protections for lenders and leaves architects with less protection and diminished rights to enforce mechanic's liens - even though the Nevada Legislature's 2003 revisions to NRS 108 (Nevada's Mechanic's Lien Statute) recognized that architects were entitled to the same protection as traditional contractors under mechanic's lien laws.

AIA Nevada, our affiliated partners and our lobbyist, Kaempfer Crowell are currently researching lien laws and working to draft language that will clarify the law for architects, engineers, landscape architects, interior designers and other related initial project services.



## RETROFITTING RESIDENTIAL LAS VEGAS: PART 4

This is the fourth of several articles that I will be sharing in the newsletter as part of the COTE Committee's ongoing effort to keep the membership informed on all things sustainable. I will be discussing the many

practical improvements that we have made to reduce our home's total energy demand by more than 70 percent (compared to a new energy code compliant home as built today).

This article will focus only on plumbing and HVAC changes that we have made to both reduce our overall energy load and to improve the indoor air quality of our desert home.

One of the first plumbing revisions that we made to our home was to add a small Grundfos circulation pump and timer on the hot water line above our water heater and add a pressure activated bypass valve located below the most distant lavatory in our master bedroom. This simple system circulates hot water (from the hot water line to the cold water line) between 6 AM and 11 AM each day so that we would have hot water quickly when we wanted to take a shower. This saves many gallons of water and it also saves energy on water heating each day.

I also consulted the DSIRE (Database of state incentives for renewables and efficiency) website for energy conservation incentives program for Nevada and noted that NV Energy offered financial rebates for changing the electric motor on our central HVAC fan to a BPM (Brushless Permanent Magnet) motor combined with an extended operation WCC (Western Cooling Control) controller. This new BPM electric motor saves approximately 50 percent electricity on heating, up to 28 percent electricity on cooling and up to 80 percent electricity on continuous ventilation. The new WCC controller saves approximately an additional 15 percent electrical energy without sacrificing comfort. The key to this new controller is altering the amount of time the fan runs (by 6 to 10 minutes) after the outside condenser part of the air conditioner (compressor) cycles off. The amount of time the fan runs is keyed to the amount of time the compressor runs.

We had our HVAC maintenance company make these revised HVAC installations and we subsequently received a \$350 rebate for the new BPM motor and a \$50 rebate for the new WCC controller from NV Energy.

At the same time, the electric motor for our exterior condenser unit was drawing significant amperage and heating up, so we also changed it out to a premium efficiency motor, which cut this amperage load by about half and extended the condenser motor life for many more years.

Both my wife and I have varying degrees pet allergies as well as seasonal pollen and dust allergies. Therefore, we have added a special Lennox MERV 16 air filtration system for our central HVAC fan unit. This filter removes 99.9 percent of all air born particles like pollen, dust and pet dander. It removes 90 percent of all air born germs and bacteria. And it removes and destroys approximately 50 percent of all air born chemical odors and vapors, from sources like pets, cleaning products and cooking appliances.

So that we could sleep more comfortably during heavy pollen times as well as the typical hot weather-dry air, we recently also added a Blueair 400 series HEPA air filter unit and a Boneco humidifier in our master bedroom.


## REGISTER YOUR LEED PROJECTS BEFORE OCTOBER 31ST!

Don't forget that October 31, 2016 is the last date to register LEED 2009 projects, after that date, all projects will be on the LEEDv4. LEED v4 was originally launched in 2013 but the U.S. Green Building Council announced in 2014 that they would delay the change to

LEEDv4 to allow industry time to prepare for the additional framework required for LEED v4 certification. LEED v4 raises the bar on green building standards, and although the market has had additional time to prepare for this latest iteration of LEED, project teams need to evaluate their options if they are on a time frame in which registration could happen under either rating system.


