

SUPPORT FOR OUR AIAS CHAPTER

As those of you that have served on a board, you know that occasionally you get asked to do something that is an unexpected pleasure and privilege. I had exactly that reaction when Dominic Armendariz, outgoing President of the UNLV Chapter of AIAS asked me to write a letter of recommendation to the judges at the National AIAS Committee for consideration of the AIAS UNLV chapter to receive the 'Chapter Honor Award'.

As far as I am aware, the UNLV AIAS chapter has never applied for any of the National Awards that are awarded annually by National AIAS before now. This year, our chapter is applying for 2 awards, the 'Chapter Honor Award' and 'Chapter President Honor Award' for Dominic Armendariz. After spending the last year interacting with Dominic and AIAS UNLV, I see both of these applications as extremely viable, achievable and long overdue.

The interaction of the AIAS Board and our Board of AIALV has been extensive and continuous throughout the year. Dominic has attended almost every one of our AIALV board meetings, sometimes with his brother Rafael joining him. BTW, Rafael is now the current President of AIAS UNLV.....these twin brothers really tag team very well. Our last AIALV board meeting had the entire new AIAS board in attendance too, with the exception of both Dominic and Rafael, who were out sick.....they really do share everything apparently.

I am pleased to share parts of my letter of recommendation below:

As AIA Las Vegas President and a professional with nearly four-decades of experience in our city, I have witnessed tremendous evolution in the region's professional and educational environment including the founding and accreditation of UNLV's School of Architecture. Therefore, I recognize the great strides our UNLV AIAS Chapter has made in just the last year.

My years on the AIA Las Vegas Board and as its current President have focused on establishing and sustaining connections between practitioners and the community with an emphasis on spreading the word on architecture and architects. I believe our mission over the next decades is to build, nurture and solidify our relationship with the professionals of tomorrow. This is how we will ensure the long-term viability, significance, engagement and success of our field. Independently, the AIAS UNLV Chapter has recognized this need and put into practice a multi-pronged approach to building a network and voice for our area's architecture students.

During the recession, every aspect of our profession was impacted with drops in first year students enrolled in UNLV's architecture program and declining membership in AIA Nevada, AIA LV and AIAS UNLV. The strategy of the 2016-2017 AIAS UNLV leaders focused on expanding the value of AIAS membership for individuals and to transform the organization into a natural pathway to sustained membership in the AIA. They put forth an aggressive agenda, partnering with AIA LV to form a robust professional-student mentorship program; create a local high school outreach program; remodel, re-open and return to stability the neglected AIAS UNLV Student Store at UNLV's School of Architecture; and establish a yearlong program of workshops to help students gain the right skills for successful internships.

AIAS UNLV put resiliency at the core of their efforts by partnering AIAS members in 3rd year studio with young, emerging professional AIA LV members in a mentoring relationship. These students and emerging professionals met regularly to discuss concerns, goals and practice, giving students a chance to hear first hand about practice from their contemporaries. Their mixer events have introduced many students to a practicing architect for the first time and increased paid membership of 3rd year students to 65%; they are now expanding this effort for second year students.

Outreach to students in the Clark County School District, the 5th largest in the country, extends into the public education system to increase awareness of architecture as a career path, along the way they started one of the nation's only AIAS high school chapters. Through this program, UNLV architecture students have given presentations to hundreds of students across the Las Vegas Valley forging lasting impressions of and connections with the profession. And AIAS UNLV partnered with the School of Architecture to establish a workshop series designed to give AIAS members the skills needed to gain meaningful internships including technical, B.I.M., digital media, conceptual sketching, portfolio building, and presentation skills as well as tours of local firms and projects.

AIAS UNLV instigated fundraising initiatives that substantially increased national conference attendance for UNLV School of Architecture students: seven students attended Grassroots Conference (a 600% increase over the prior year), ten at Forum Boston (a 400% increase), six students attended West Quad in Portland, and AIAS UNLV President Dominic Armendariz represented UNLV at the Top 60 at 60 Conference in Orlando.

AIA NEVADA PROMOTES LOCAL FIRMS FOR LVCC AND STADIUM PROJECTS

The design, planning, development and construction of the Las Vegas Convention Center Project, and the Las Vegas Stadium will greatly impact all of Nevada architects and design professionals.

The Las Vegas Convention Center Project is a major expansion and renovation of the Las Vegas Convention Center to accommodate current customer needs and capture future tradeshow opportunities. The 1.4Billion dollar project consists of four phases extending to 2026. The Las Vegas Stadium will be the home of the Las Vegas Raiders, is a 1.9B project and is planned to be completed by the 2020 NFL Season. Each of these projects has the potential to engage local firms and create jobs for thousands of Nevadans.

AIA Las Vegas Executive Director, Randy Lavigne, Hon. AIA and members of the Chapter, have attended meetings of both the Oversight Panel for the Convention Center, and the Las Vegas Stadium Authority Board in order to publically request that local architects, engineers and design professionals be included in every phase of these projects. The following are the bodies of the letters that were delivered and read into the minutes of the meeting of the Convention Oversight Panel on Thursday, May 11th, and the Las Vegas Stadium Authority Board later that afternoon.

Dear Board Members, Oversight Panel Members and Staff of the LVCVA,

As an honorary member of the American Institute of Architects (AIA) and its 90,000 members; as Executive Director of the AIA Las Vegas and AIA Nevada Chapters; and on behalf of the 2,901 architects who are licensed, registered and practice in the State of Nevada, I am asking that you recognize, acknowledge and engage the abundance of talented, nationally acclaimed and respected architects that live and practice right here in our own state and provide an economic benefit with each and every project they design. They lead firms that offer a collective history with convention, hospitality and entertainment venues that exceed hundreds of years.

When Nevada architects work . . . the whole design and construction industry works. Projects that begin with the architect's design concept generate jobs for contractors, engineers, consultants, interior designers, landscape architects and others, who in turn hire the construction workers, the sub-contractors, suppliers and manufacturers . . . and so on. For every \$100M of capital funds invested in our state's building infrastructure, we create jobs for 6,000 Nevadans. It begins with the architect and ends with a healthy economy.

Of the 2,901 registered architects in the State of Nevada, 537 are residents who live and practice in our state, create jobs and contribute to the economic well-being of our communities through their practice. We understand that SB464 is intended to be a benefit for local "small" businesses, however, the required qualification for architecture and engineering firms to earn less than \$2.5M in annual revenue causes concern when used to qualify a firm's capacity, capability and experience. That qualification should not become an impediment to our local firms with the portfolio and experience qualified to play a major role given the intended scope of both the expansion and renovation of the LVCC. Furthermore, the requirement that 15% of the project be subcontracted to small local businesses should be a minimal guide only. Local firms regardless of size and income should be given the opportunity to participate on a project whose objective is to keep the Las Vegas brand and it's Convention Center on top and ahead of other competitive convention and tourism markets.

The 550 architect, associate and allied members of the AIA Las Vegas Chapter represent a diverse range of firms, large to small, whose specialties and breadth of professional experience cannot be calculated by an arbitrary revenue amount. These firms are prepared to provide exceptional design, planning and construction management services for the Las Vegas Convention Center (LVCC), and are truly interested in advancing the vision of the LVCC into the future. They are invested in this community just as the LVCVA is, and should play an integral role with this extraordinary and significant project.

It is our hope that the Board of Directors and the Oversight Panel for the Las Vegas Convention Center will engage local architects, engineers and design professionals in this project which will result in the most successful outcome for our Las Vegas and Southern Nevada communities. Thank you.

The First Place Low Gross winners were the Sletten Construction Team of Doug Kanopic, Randy Smith, Chip Madsen and Chris Lamb.







“What’s in a title? That which we call an *intern*, By any other word would *draft* as sweet.”

Have you heard?! After years of research and debate, the AIA has updated its position on the use of “intern” within the profession:

“Intern” should be regulated to current students working within an office. Professionals out of school, but before licensure, are to be titled either “Architectural Associate” or “Design Professional”.

While the AIA acknowledges the institute has no authority to regulate such titles, the intent was to push the conversation into the mainstream and open a dialogue concerning engrained semantics. Unfortunately, the conversation has gotten off to a rocky start. Last month the NSBAIDRD (Nevada State Board of Architecture, Interior Design and Residential Design) issued a notice that the use of the title “architectural associate” or “design professional” by interns is a violation of Nevada law. From my own conversations, it seems sides are generally being drawn along the “licensure-line”: those who are currently licensed agree with NSBAIDRD and believe changing pre-licensure titling is a non-issue, while those not yet licensed believe the perception of titles within the professional is conversation worth pursuing.

What are your thoughts? Does this affect you? How does it affect you? What’s your position? With that, the AIALV-EPYAF has established an online discussion board; specifically for these types of issues. We believe it is vital to start an open dialogue concerning current items that affect our profession – especially ones related to Emerging Professionals (students, associate AIA members, and newly licensed architects):






