**I am a member of AIA because...** on my second day in Las Vegas in July of 1979 Robert Fielden, FAIA brought me to a Las Vegas AIA meeting. At the meeting I was elected Secretary –Treasurer. After eight years of board service I understood the important contributions that AIA makes to the profession, the community and individual practitioners. I am a committed AIA member for life.

I am currently working as an Architect-Developer. I am designing and developing mixed- use projects in downtown Las Vegas. On my first project I teamed up with partners to develop El Benjamin, located at 6th and Bonneville. The project is a mix of townhouses, office space and a restaurant. Currently under construction it is scheduled for completion in April 2018.

From 1979 through 2011 I was part of JMA Architecture Studios. JMA was recognized as a regional design firm once ranked the 45th largest architecture firm in the US. As President and 100% owner I sold JMA in 2011.

As a practicing principal Architect the most important thing I have learned is not to be afraid to turn down a project. The projects you accept form the basis of your future career. The wrong project can produce the wrong

career.

As an architect developer in the next twenty years I expect I will have completed dozens of mixed use projects. I expect I will continue this effort beyond then but perhaps at a slower pace.

In the next five to ten years I am hopeful that a greater percentage of architects will foster a stronger collaboration with contractors in pursuit of architect led high quality design projects.

I believe AIA can lead reform and innovation through a commitment in support higher education for the architecture and design industry. Support of the UNLV School of Architecture will allow practitioners to advise in program development and to mentor upcoming professionals. I know of no better way to lead innovation.

The Student Chapter of the AIA (AIAS) at UNLV School of Architecture has taken a lead role in speaking to Clark County Students on a separate, but parallel path. Under the leadership of Dominic Armendariz, this last year has been very successful, with many speaking opportunities to Middle and High Schools and perhaps most impressive, the creation of an AIA Student chapter at the East Career & Technical Academy, joining Advanced Technologies Academy as the 2nd AIAS High School chapter in Las Vegas.

**High School Design Competition:** We are working with Ryan Sisti as he once again prepares and leads this 45th annual high school design competition. Glenn Nowak has reached out to Skills-USA to garner interest and participation throughout the state. We have broadened the number of schools that are now aware of this competition and are planning on participating. In the past, we have had as many as ten schools participate, but with the loss of drafting education throughout the district, the number of schools participating has plummeted to a low of three schools participating in 2013. This year we have at least six schools participating and we look forward to a wide array of creative design solutions to Ryan Sisti's design challenge at our April meeting where we will announce the winners during our Art, Architecture & Design month.

**AIALV Principal Shadow Program:** This program, administered through AIALV and UNLV SOA (thank you Glenn Nowak) pairs 6th year graduate students and a participating architectural office. The intent of this pairing is that the student will spend time during a normal business day with a principal or other key individuals, in the real world setting of architectural offices, meetings and conferences. This program is semi-structured to allow maximum flexibility for both student and professional offices to coordinate hours spent in the office, days per week and length of experience. It is suggested to limit this experience for each student from 1 day to 1 week, allowing the student to experience multiple principals and offices; and concurrently, providing each participating office with the opportunity to meet and get to know different students that will be graduating in the near future. For students that only have limited time outside of their studies and other responsibilities, having the chance to be immersed into a firm's culture for just a day or two provides great insights to the different work environments within the profession.

I am pleased to announce that Atlas Architecture, BWA, Zimmerray Studios, SH Architecture and Gensler & Associates have volunteered this year. Thank you Brett Robillard, Leonard Bergman, Harry Ray, Eric Roberts & Stephen Ranck.

AIALV welcomes anyone that is interested in getting involved with any of these programs to please contact the office. The future of architecture is sitting in our elementary, middle and high schools right now and they want to know what you are doing.





**Council of Excellence Re-activated**

AIA Las Vegas has a long history with the UNLV School of Architecture, and the Chapter has always been the bridge between the profession community and the School. This year, to formalize our support of the School, Tom Schoeman, AIA conceived, initiated and organized a the UNLV School of Architecture Committee, which was approved by the AIA Las Vegas Board of Directors earlier this year. The official mission to serve as a liaison between practicing professionals and the UNLV School of Architecture. The goals of the Committee are as follows:

- **Communicate** – Orchestrate informational discussions between the director and faculty of the School with practicing professionals and related design community.
- **Advise** – Act in an advisory capacity to the director of the UNLV School of Architecture
- **Mentor** – Lead the student mentorship programs for the school
- **Fundraise** – Manage an annual fundraising campaign to benefit the School of Architecture
- **Advocate** – Professionally advocate for the School.

One of the main objectives of the Committee is to re-activate the School's Council of Excellence, made up of AIA members and alumni to assist in achieving the stated goals. 

**DO YOU HAVE ALL YOUR HOURS?**

Licensed architects must earn continuing education credits every year to satisfy AIA membership requirements, and renew their state license. Continuing education is measured in Learning Units (LUs), one LU equals one hour of continuing education. Licensed AIA members must obtain 18 LUs, and at least 12 of those must be in the topic areas of health, safety and welfare (HSW).

Licensed AIA members must obtain 18 LUs, and at least 12 of those must be in the topic areas of health, safety and welfare (HSW).

AIA offers a wide variety of courses that can help you earn continuing education credits, and keeps track of your learning progress. When you take AIA-approved courses, provide your AIA member number and your AIA member transcript will be updated for you. There are more than 3,000 continuing education providers and more than 75,000 approved classes that can help you obtain the required credits. You can even earn LUs by reading magazine articles and passing an online quiz. Each publication provides its own links and instructions to receive credit, and providers have up to 10 business days to report course completion.

Full-time university faculty members can also earn credits for self-reporting research and preparation time for presentations, speeches, and classes they teach. Full-time university faculty members can earn credit classes that they teach outside of their normal work assignments, and Part-time faculty can apply for credit for teaching a course only once every three years if the course is taught multiple times. AIA awards 15 LUs for each course semester hour.



If you fail to meet the continuing education annual requirement, you will be given a nine-month grace period through September 30 of the following year. Any credit earned during the nine-month grace period will apply towards the deficit from the prior year and not to meeting the current year's requirement. To learn about your current status, log in to your account on the AIA website, and look under the Education & CES tab. You'll be able to view your transcript and print it. So, don't wait! Make sure you get those hours in on time!





## RENEWAL REGISTRATION DUE DECEMBER 31, 2017

As a courtesy, registration renewal reminders were mailed out the first week of October. The letter that has been mailed in previous years has been replaced with a postcard and is the only reminder that will be sent out.

Beginning in 2020 (for 2021 registration renewal) reminders will be sent out in electronic format only. It is important that registrants keep their email addresses up-to-date with the board office in order to receive notifications. Submit a Change of Address Form to the board office at [nsbaidrd@nsbaidrd.nv.gov](mailto:nsbaidrd@nsbaidrd.nv.gov) if your contact information is not current or upon it changing in the future.

Registrants have the option of renewing online or mailing in the three page renewal form which may be downloaded from NSBAIDRD's website.

### Important things to remember:

- Nevada registrants must complete eight continuing education units (CEUs) in the areas of health, safety, and welfare (HSW) each year. For further information read the continuing education section of NSBAIDRD's website. Do not select that you are in compliance with the previous year's HSW CEUs unless you have completed the CEUs and have documentation to prove it.
- Nevada has no grace period for registration renewal. Registrants not completing the renewal process by December 31, 2017 will have their names dropped from the active registrant list and forwarded to Nevada building departments.
- Renewal fees and forms received after December 31, 2017 will be assessed a late renewal fee of \$220 in addition to the annual renewal fee of \$150.

## AT HOME WITH HUGH

"So where does one go in such a wobbly, elusive, dynamic, confusing age? Wherever the librarians and archivists are. They are sorting it all out for us." -Marilyn Johnson

Contrary to popular thought, archives are not a final resting place for items of historic interest. They are living, breathing entities that hold a world of wonder for anyone who takes the time to explore them. They teach us about ourselves and about the world we live in. They are always waiting for us to discover them.

Imagine then discovering the knowledge about fabulous Las Vegas when the Hugh Taylor Collection came to light! The Taylor Archives represent something truly unique, even against the greatest archives of the world; it was meticulously kept by its own creator, and it was bequeathed by that same individual to Nevada Preservation in 2014.

Hugh E. Taylor arrived in Las Vegas in 1949. He was brought to here by Wilbur Clark in order to take over the design of his new Desert Inn Casino and Resort. Taylor's fondness and love for our beautiful city was immediate, and he never left. He went on to design hundreds of architectural projects throughout the Las Vegas Valley, leaving an indelible mark on the city as it developed from an oasis in the desert into a sparkling, burgeoning city. He passed away in October of 2015, after leaving his collection of original drawings for all of his projects to Nevada Preservation Foundation.

Exploring the Taylor Archives is as though you are getting to know the man himself. Each cabinet and room was laid out with loving care and passionate attention to detail. From a Ranch-style home in Paradise Palms to an English Cottage-esque sump cover, a classic movie theater to a bomb shelter, looking at his drawings is like stepping into a mid-century time machine and walking down the very corridors that he designed. One can imagine Taylor in his offices at 1818 Industrial Way, sketching out each line, guiding the pencil along the vellum with a master's guiding hand. It is no wonder that someone like Hugh Taylor changed the face and the history of a city.

Thanks to the generous contributions of supporters like you, the cataloging of the Taylor Archives is now officially complete. Our goal for 2018 is to digitize the full collection in order to make it accessible to the public for research purposes. This will aid in the preservation of the archival drawings themselves, as it will minimize the physical handling of the original documents. In 2018, our ultimate goal is to move the entire collection to its permanent home at the Nevada State Museum within the Springs Preserve, but we cannot do it without you! And you would be surprised at how far we can make your donation go!


