AIA LAS VEGAS PRESIDENT'S MESSAGE

As I write my final President's Message, I am reflecting on how 2020 has been an unbelievably crazy year. This year goes down as one of the most challenging and unpredictable years I can recall. Like many organizations, AIA Las Vegas had to overcome obstacles and face its own challenges this year due to the coronavirus. We were able to react and act rather quickly and move from in person to virtual events. More importantly, we found new and unique ways to connect with our AIA and Allied members, as well as the Las Vegas community.

2020 was also about a year of focus on CLIMATE CHANGE: Taking Action to Transform the Practice of Architecture. With buildings generating nearly 40% of annual global GHG emissions and the global building stock expecting to double in area by 2060, architects are uniquely positioned to play a key role in developing solutions to eliminate carbon emissions. It is expected that we will add 2.5 trillion square feet of new floor area to the global building stock in the next 40 years.

One of the goals this year was to increase the number of firms who are signatories of the AIA 2030 Commitment. We started the year with four firms as signatories and I am happy to report the Nevada firms who have signed on to the AIA 2030 Commitment has tripled to 12. Thank you to the firms who have stepped up and made a commitment to designing for energy efficiency and carbon neutrality by 2030.

Although we are continuing to work on our climate action goals and objectives, this year, in spite of the pandemic, we have managed to bring in national speakers who are addressing climate change in architecture and design. The year started off with Marsha Maytum, FAIA of Leddy Maytum Stacy Architects in San Francisco and continued with Tate Walker, AIA, Director of Sustainability at OPN Architects. We also were fortunate to hear from Vincent Martinez, COO of Architecture 2030 and concluded with Ed Mazria, CEO of Architecture 2030.

Earlier this year, AIA Las Vegas hosted a panel discussion, What are Las Vegas and Nevada Doing to Combat Climate Change, which included Nevada State Senator Chris Brooks, County Commissioner Justin Jones, Jennifer Taylor from the Governor's Office of Energy, Marco Velotta from City of Las Vegas Planning, and Kristen Averyt, who is a Climate Change Policy Coordinator at the State of Nevada and Research Professor at UNLV.

Additionally, we hosted the AIA + 2030 Virtual Fall Education Online Series Certificate Program. The series educated and inspired 15 AIA Las Vegas members to meet the 2030 goals through design strategies, efficient technologies and systems, and renewable energy resources.

All of these programs focused on addressing climate change and what we can do as architects and design professionals in Southern Nevada to create carbon neutral buildings by 2030. We still have much work to do, but I am confident the Las Vegas A/E/C community can drive the change that is necessary to meeting zero carbon goals in this decade.

This year also showed me what a dedicated, strong and resilient AIA Las Vegas chapter looks like. I would like to thank Randy and Kelly Lavigne for their leadership, guidance, friendship, and dedication to the constant success of AIA Las Vegas.

Thank you to the AIA Las Vegas Board of Directors. It has been my privilege to work alongside such a wonderful and committed group of individuals.

Lastly, I would like to thank James Horvath for his support and wish him all the best as the 2021 AIA Las Vegas President. James has wonderful plans to connect and build a stronger AIA Las Vegas chapter.

Finally, I would like to thank all the members, colleagues, friends, and supporters of AIA Las Vegas. It is with your continual support this organization has been able to succeed for over sixty years. Thank you AIA Las Vegas for allowing me to play a part and write a chapter in your bestseller.

As always, stay healthy, stay positive and stay Vegas Strong! I will see you in 2021.
